### **Highlights of the Forty-fourth Triennial**

1. Issuance of two Charters for Grand Councils (Croatia and France), one Charter for a Subordinate Council (El Salvador), and one Replacement Charter for a Grand Council (Germany).
2. The revised Constitution and By-Laws resolutions passed with only minor amendments to the proposed By-Laws.

3. Per Capita remains at \$1.00 for North American Grand Councils, \$1.50 for non-North American Jurisdictions, and \$1.00 for Subordinate Councils.
4. The Life Membership has changed to where it costs 25 times the Per Capita for your Grand Council (\$1.00 or \$1.50).
5. Full credit on the Annual Return will now be allowed for the General Grand Council Life Members for your jurisdiction after Per Capita is paid on them one time. This applies to all Grand Council Assemblies after 29 August 2011.
6. Procedures have been enumerated for establishing Subordinate Councils and then establishing Grand Councils.


A copy of the Constitution and By-Laws will be posted on the General Grand Council Web Site after some grammatical and reference corrections are made.
