MINUTES OF THE 190^{TH} ANNUAL ASSEMBLY GRAND COUNCIL OF CRYPTIC MASONS OF THE STATE OF NEW YORK

The 190TH Annual Assembly of the Grand Council of Cryptic Masons of the State of New York was held on Friday, August 16th and Saturday, August 17th, 2013 at the Clarion Hotel, Batavia, NY.

OPENING AND RECEPTION OF GRAND MASTER AND OFFICERS OF GRAND COUNCIL:.

A Council of Select Masters was opened by the Illustrious Master and Officers of Nun Da Waga Council No. 92 on Friday August 16th at 7:30PM. The Most Illustrious Richard Anderson, Grand Master, and the Officers of the Grand Council were received, and by order of the Grand Master. MIGM Anderson was greeted with Private Grand Honors he orderd all Grand Line Officers to assumed their stations and places in the Council.

OPENING OF THE ANNUAL ASSEMBLY OF GRAND COUNCIL:

A constitutional quorum of constituent Councils was determined to be present, and the Grand Master declared the 190th Annual Assembly of the Grand Council of Cryptic Masons of the State of New York opened in ample form. In accordance with New York State Fire Laws, he then advised the Companions of the exits in case of emergency. The MIGM Anderson Advised all Companions present that they must register with the Credentials & Registration Committee in order to vote...he advised all present that the Registration desk was located in the main lobby. MIGM Anderson stated he would allow all Councils a vote even though some Councils had filed late Returns...a point of Order was raised by MI Richard Hadley, PGM & by MI Harvey Payne, PGM that MIGM Anderson could not circumvent the General Regulations or By-Laws to allow the delinquent Councils a right to vote at the Annual Assembly. The MIGM Anderson order the Grand Recorder then read the names of the 8 delinquent Councils were not eligible to vote at this Assembly190th Assembly. Columbian #1, Rotica #12, Doric #19, Ahwaga #30, Joseph Warren Cryptic #37, Flatbush #80, Oneonta #87 and North Shore #88 for failing to submit Annual Returns or Election forms by July 10th.

The Grand Master then appointed a Credentials Committee, consisting of R : I : Kenneth E. Kohlhagen as Chairman, together with R : I : Jerold A. Brade, and R : I : Vern Rupert. Ill. Dennis Parmerter, Comp. Michael Rhodes, Comp. Robert Ball.

The Grand Master appointed a Committee to reply to the Grand Master's Address, consisting of M : I : David Raymond and M : I : Lester G. Weinheimer and M : I : David B. Roberts.

- 2] The reports of the elected Grand Line Officers, from Grand Principal Conductor of the Work to Grand Steward inclusive, as will be published on the 2013 Proceedings CD, be approved.
- 3] A Motion that all Companion Select Masters in good standing be invited to remain as visitors to this Annual Assembly, except are such time as provided by the Constitutions.
- 4] A motion that the Election of Officers be the Order of Business at 1:45 PM on Saturday, August 17, 2013; and that nominating speeches be limited to three [3] minutes and that seconding speeches to two [2] minutes.
- 5] A Motion that our visiting Grand Masters and Past Grand Masters who are not already Honorary Members of this Grand Council be made so.
- All Motions were made, seconded and passed unanimously.

Article I Section 10-1 9c0 Change the statement to read- To receive, duly file and safely keep all papers and documents of the Grand Council. <u>To receive all requests for dispensations, prepare and submit same to the Grand Master for his review and approval.</u>

Article III section 46- A Committee on Jurisprudence, to consist of three (3) or five (5) Members.

A motion was made seconded and pass unanimously as accept the report as read and explained.

REPORT OF THE GRAND FRATERNAL CORRESPONDENT:

REPORT OF THE GRAND TRUSTEES:

[cont] hand out. M.: I.: Harrison spoke on the Escrow Fund and the Operating Budget. After a short discussion...a motion was made and seconded to raise the Grand Council per capita dues by \$5.00 to \$20.00 per year, a question was called...after a long and heated discussion on the motion, a second motion was made to table the first motion for a year. A vote was called for results were 32 to table with 15 against tabling, the matter was tabled till reach on the increase could be conducted and the matter will be held over till the Annual Assembly #191 in August of 2014.

MIGM REPORT 2014

I began this report several times, there have been multiple revisions as my reflections as Grand Master have fluxuated, these last few weeks. First I am pleased to report that to the best of my knowledge, the Constituent Councils have improved. Adoniram Council No. 36 in District No. 1 has submitted a new set of by-laws which have been accepted and approved by the Juris Prudence Committee. Their new meeting location has been established in Whitestone Masonic Temple for this fall.

Ahwaga Council No. 30 in District No. 7 has submitted a change in their by-laws to relocate their meeting location to Vestal, NY. It appears that there is increased interest in Council participation in this area.

There was a discussion because three demits had been requested after they had decided to relocate. Therefore, I contacted the Illustrious Master to verify the reasons for these demits and requested he contact the Worshipful Master of the Lodge they were renting from to resolve any questions that had arisen in the Council. After he had lunch with the Master it was determined that the problem of having the entry door unlocked prior to meetings and having the heat on or available to be increased for meetings was an oversight on the part of a member of the Lodge. The decision had been made to relocate and there was no desire to continue at the original location so therefore the dispensation was issued.

King Hiram No. 18 in District No. 6 has relocated to a new location in Seneca Falls to hold their meetings. During the last few years they have been plagued with numerous problems relating to the previous building they used.

I issued eight dispensations this year, the majority of which were mostly for holding meetings on non-meeting nights or a different location than where the regular meetings were held. Two were for the relocation of the two Councils.

While discussing demits, it brought to mind a concern I have regarding demits. Presently, the process for a demit is to submit the request to the Council Recorder and it is usually immediately granted. I recommend that each Council should have a committee to review demits. This would provide at least one member who could politely contact the person making the request, to see if the Council could possibly help in resolving the situation to avoid that membership ending.

Needless to say, the individual making this contact must be discrete and only share information of this type, on a need to know basis, to possibly resolve the potential loss.

I am not aware of any other Councils with serious problems. However, some Councils have a looming crisis such that their membership has not been replenished over a period of time. One of the suggestions I made this year, on my visits, was to develop a group that would put on the "What is Cryptic Masonry" as a program for Chapters and Commanderies as an informative program. This program is very similar to the Fervency and Zeal Program sponsored in RAM Chapters. This could be by

organized in or by Councils and/or Districts. It could be a solution and means to get companions involved while improving membership and with the additional benefit of being educational.

During last year as Deputy Master, I heard multiple discussions about the large quantity of candidates awaiting completion of the requested appointments as Grand Representatives. I suggested to the Grand Recorder that this year I would take the responsibility of clearing out the backlog of appointments. I am pleased to report that all names proposed have been submitted to Sister Jurisdictions and several have been returned as accepted. There was also one long delayed Companion submitted for a candidate from Texas and then this year two more names were also submitted, one from Massachusetts and one from Pennsylvania. These candidates have been sent their commissions.

There was a growing realization that we needed to document the entire Grand Representative process to give us a written procedure in place to allow the process to flow smoothly. This would be vital for the future proposed candidates from New York or those from our Sister Jurisdictions.

An effort was put forth to prepare an SOP (Standard Operating Procedure), to be used. It includes templates for all necessary letters of communication for all personnel involved. There are also Commission certificates for those from Sister Jurisdictions that only need the pertinent information added.

For this coming year, I have suggested that the new MIGM, Harley DeShane, use one of the Line Officers that has been involved this year. I believe that by appointing one person, the continuity will be maintained.

A beneficial side effect of this effort has already shown up as an increase in names of candidates submitted this spring from our own Councils and from Sister Jurisdictions.

Many other procedures need to be covered with an SOP so that we are not dependent upon memories of a single individual if he encounters a serious problem. Quite a few problems have shown up this year and could have been avoided. With the transition between Grand Recorders during the last few years, not only the Grand Recorders and Constituent Council Recorders but everyone else throughout the State have felt the loss of vital information. This cannot be accomplished in one year but it would make life much simpler and less rigorous.

After discussions with RI John Gallant about making the WEB Site a more viable tool for all members in our Council, he added many items to the WEB Site including the Officers Manual, forms used by most members, particularly, the officers of Constituent Councils, District Deputies, Assistant Grand Lecturers and Grand Line Officers. He also initiated a regular update of information so that the WEB Site is current daily.

An additional value or benefit of putting more information on the WEB Site is that it will be more difficult to loose or misplace, especially that prepared for and by future generations.

The WEB Site should always remain an entity under the control of the WEB Master and never married to another function or individual. With it standing on its own legs it will augment the information needed to operate efficiently.

This next item I believe needs to be resolved. That is the need to have a pre-entry discussion between new Cryptic candidates and the Grand Line Officers. A thorough discussion would be advantageous so that the candidate understands what will be expected of him if he is accepted. Both parties need to know what each other expects. The lack of compliance after "the decision is made" would provide both parties to intelligently discuss the difference of opinion.

This term I completed a task I have waited several years to complete. I completed my visitations to all New York Councils. I had never been assigned to visit District 1 and I was looking forward to getting the opportunity to visit it.

Unfortunately, over the years, I missed two Councils in New York.

Several years ago when I visited Union Council, they did not have enough members present to open.

This year I could not visit Adoniram Council because they did not have a place to hold their meetings.

However, I did visit five of the six Council in District 1.

In all Councils I have visited over the years, I was always greeted as a friend and Companion. This was especially true this year as I was visiting various Councils in District 1, I repeated visits to Councils some I hadn't visited in years. I revisited Goshen, Oneonta and Ahwaga.

During my travels this year I became an Honorary member in several Sister Jurisdictions. They were Rhode Island, Ohio, Pennsylvania, Connecticut, Vermont and Ontario, Canada. In each I was received as if I lived there.

I also found time to visit old friends in Albany at the Grand Chapter Annual Convocation, Grand Commandery Annual Conclave in Kehonkson and Grand Lodge Annual Communication in New York City.

I also had the pleasure to visit The Rainbow Girls Annual Installation in Ellenville.



The Annual Report from the Deputy Grand Master 2013-2014

First, I. Went to Awaga Council No. 30 on September 24th as they were having a Summons meeting on whether to change there meeting place from Owego to Vestal.

REPORT OF THE GRAND RECORDER 2013-2014

TO: The Grand Council of Cryptic Masons of the State of New York

I would like the thank the Companions present at the Annual Assembly in Batavia, NY in August 2013 for reelecting me to the Office of Grand Recorder.

Grand Representatives: This past year started out where the last year ended with correspondence being received by me about Grand Representatives requests for appointments over the past several years which were never acted upon. MIGM Leonard Mason decided to help me with the clearing of the backlog by asking RI John Gallant, DDGM 8th District to help design a certificate which we didn't have on file. MIGM Mason started going over the list of Grand Representatives which was out dated...it was found some Companions had passed or moved or were non compass mentis. It was a giant undertaking but the list was whittled down...certificates were made, letters sent and new Grand Representatives were appointed by our jurisdiction and new Grand Representatives were greeted from sister Grand Councils.

I have to give a giant <u>"THANK YOU"</u> to these Companions for all the work that was done by them to help me.

Annual Election & Annual Return forms: This past year I edited the Election form to have Council Recorder add titles for all Officers and an circle yes / no if the Ill. Master needed the Tim degree. Both items were highlighted in neon yellow so that they were seen. You can't believe how many Recorders sent back the Election forms not filled out properly. Changes were also made to the Annual Return forms...same problems.

This year I sent out three [3] separate mailing for the Election forms...Annual Return forms...and the Call for the Annual Assembly. All the envelopes had "ADDRESS CORRECTION REQUESTED" on my return label. This was done due to Recorders telling me last year [2013] that they didn't get the one big packet. Would you believe I still got the same "I didn't get the package" till I advised them there were three separate mailings? What I can't fathom is the lateness of Recorders to send in their reports on time. This year is no exception as we have several Council who lost voting privileges due to not sending in their reports.

RECORDER PROBLEMS: This past year several Council Recorders reported that they had problems with the Companions reported on last year's [2013] Annual Returns report. One Council found out that the previous Recorder hadn't collected dues in 3-4 years, or reported deaths or demitts, or NPD's for the same period of time. When the books were placed back into order it was found out that the Council had a deficit of fourteen [14] Companions. The same problem was found by another Council but the losses weren't that great.

It is my recommendation that each Council should appoint an Assistant Recorder and a Assistant Treasurer to assist both Officers in their duties. Grand Lodge allows the position of Assistant to the Secretary and Assistant Treasurers office. We should do likewise, in case of an emergency or death to either officer. So that the location of records and property is known. That is why the Grand Council has an Assistant to the Grand Recorder just in case of any issues that may arise due to health or problems to the Grand Recorder.

We also have a problem with Council Recorders sending in the wrong form to report the passing of a Companion. There is a "Death Notice" form to report the passing of a Companion. It can be found on the website under forms. To many Council Recorders are sending me page 3 of the Annual Return Report to report a passing...the only problem with that is they then forget to add the passing on to their Annual Return report. A local Council Recorder sent me his return and forgot to report the passing of two [2] Companions as he had sent the wrong report to me. I will send the Death Notice form to all Council Recorders in September.

<u>COUNCIL RECORDS</u>: With the help of MI Paul Matthews former Grand Recorder, we have found the "old" Grand Council files on the new PC. With the files created by past Grand Recorder Pozefski I now have a better handle to redoing Council membership records. I will now be able to make out spread sheets for all Councils. Several Council Recorders have sent me membership info on spread sheet form to assist me. Right now we have lists in 3 X5 card files, numerical lists and Council file list that were not kept up.

RITUAL BOOK CHANGES: Changes were proposed at the Annual Assembly and the Companions present voted to accept the verbiage changes. New pages have been printed and I will be sending the replacement pages to the Council Recorders in September to disseminate to the Companions.

Personal issues: It is said the road of life is paved with good intentions. This past year my Lady Chris and I had to be the worst year of my lives health wise. Lady Chris suffered a stroke in late September '13. In December I fell victim to food poisoning and bronchitis which went into double walking pneumonia...which went septic into a full body of blood poisoning and I had to go into the hospital for a week. The septic anti itching and antibiotic medications had me unable to function for several weeks. We thought all was going well till Lady Chris torn her knee and had to have surgery to repair the tear. Two weeks after the surgery she suffered a second stroke...and I came down with Whooping cough and was in quarantine for eight days. I thought all was well and then relapsed for another quarantine period. It was later that my doctor told me that half the people over 65 don't survive whooping cough...and that I was lucky after having the pneumonia problem.

I want to thank all the Grand Council Officers and Constitute Council's who understood our health problems and to the Companions who sent cards or called us to see how we were doing during our recuperating period. It means a lot to know someone is thinking about you!

If I am lucky enough to be reelected to the Grand Recorder's position I will do my utmost to continue bringing the Office into a smooth working position.

The financial market this year has shown strong signs of growth. We had an increase of \$12,317.33 in the Permanent Fund or a 10.05% increase since our last Annual Assembly. We are looking closely at the market because with record highs we may be due for a correction in the market.

The Trustees realize that the 2014-2015 Budget for the Grand Council may need resources from the Permanent Fund and therefore allocates \$5,000.00 - \$7.000.00 for such. Grand Council must plan <u>now</u> for its financial future. Your Trustees were charged at the 2013 Annual Assembly to review the financial history and make a suggested and sound proposal concerning Grand Council Per Capita for the coming year (See attached documentation). It is our recommendation that a <u>SEVEN DOLLAR increase in Per Capita</u> be adopted to cover anticipated increases over the next several years and it be implemented to address the long term budget concerns.

Finally, we remind the Grand Recorder that the current Grand Council Officers' & Past Grand Master jewel/apron forms must be signed and be current each year for such current and past Officers. We encourage all Present and Past Grand Officers to have a rider on your homeowners insurance to cover the cost of replacement of the property held in your trust (jewels, collars, aprons and etc.) if lost or stolen. We also thank R.: I.: Harley DeShane for his generous advancement of funds for the purchase of new Grand Line Officers' jewels/aprons//cases and the Trustees are working on a plan to reimburse him for such but we remind the

Grand Line they should avoid making decisions on major unbudgeted expenditures without the input from the Finance Committee and the Trustees on a plan for payment for such major unbudgeted expenditures.

Grand Council of Cryptic Masons of the State of New York Grand Lecturer & Ritual Committee Report 2012 – 2013

At the 2012 Annual Assembly, two proposals for changes to the ritual were presented. The committee recommended in favor of one and against the other. Grand Council voted to approve the former. Thus far no proposals have been received by the committee for consideration at the 2013 assembly.

In the past year, Festivals and Conventions were held in some but not all Districts. At a Convention, one Companion stumped us with this question: in Cryptic Masonry, is there a voting sign, other than that used in Lodge? Recourse to references and well-informed Companions has turned up nothing; if any reader of this report has a contribution to make on this topic, please contact us. In the coming year, Festivals and Conventions will be held in each District, or jointly by adjacent Districts.

In my travels around the jurisdiction, I have found many zealous Companions, but have yet to witness a single Council opening with letter-perfect ritual from memory. While it is understood that exigencies such as the unexpected absence of an officer may require that a Companion be prompted or refer to a code book, this should be the exception; sadly, for several years now in our jurisdiction, it has instead been the rule.

Our ritual is what distinguishes us from all other organizations. It is the means by which we transmit the unique message of Cryptic Masonry. It is the structure into which we pour our energies to provide the transformative experience that an initiatory degree should be, that it *must* be to have any value to the initiate. If we do not do it well, we are wasting our time and allowing our Craft to degenerate into nothing but an empty vessel.

Leaders and great men formerly sought to be accepted among us; now they mostly evaluate us as having nothing to offer them. Young men are joining Freemasonry in search of something. Some candidates are better informed esoterically than those of us conferring degrees upon them. Masonic education does not end, but begins, with ritual.

To address this, the Custodians of the Work in Grand Lodge have launched the Ritual Renaissance program. Perhaps Grand Council should do something along these lines. Whatever else you do in Cryptic Masonry, we ask you to remember the central and essential role of our ritual, and to give it the respect, attention and effort it deserves.

The following is the Report of the Grand Fraternal Correspondent for the Cryptic year ending August, 2014.

As I am revisiting this office this year, I would like to thank Most Illustrious Leonard Mason for the honor of serving as Grand Fraternal Correspondent. It has been a privilege to be one of your officers. Please accept my thanks.

The Proceedings of 1 jurisdictions of Cryptic Masons or Royal and Select Masters on your behalf. Analysis has been done with an eye towards subjects, issues, problems and ideas that we may discuss among ourselves, both formally and informally. In addition, we are always looking for things that are interesting, unusual and fascinating.

Over the past few years, there are two major themes which have become apparent.

The first area concerns the declining membership. For many years, we have credited death as the major cause of attrition in our ranks. As we can see within this report, the Grim Reaper can still be credited with stealing our membership, oftentimes a considerable percentage. However, the categories of "Dimits" and "Suspensions" show results that the drop in then current membership can be credited to an act of conscious choice; that Cryptic Masons are *choosing not to continue* their memberships.

This writer has additional data suggesting that this is also true in Royal Arch Masonry and the Knights Templars.

"Good Communication" is always an issue and an area of concern. However, from the reports that I received from the Grand Representatives of the jurisdiction with whom we are in amity, these companions are not in touch with their counterparts in those jurisdictions or with the jurisdictions themselves.

ANNUAL REPORT OF THE JUDGE ADVOCATE

Most Illustrious Grand Master, my Grand Council Companions, and all my Companions: The 2013-2014 Cryptic year, has been relatively quiet. The only legislation that has been proposed (as at the date of this writing) are amendments to the General Regulations (set forth below), a propounding of which has been sent to every Illustrious Master and Recorder in the State. No formal opinions were issued this year, but frequent consultations and conferences with the Grand Master were had on general matters, and as in past years, requests for informal advices and opinions were rendered to the Grand Recorder's Office, with the permission of the Grand High Priest.

As we have experienced this year, we receive, almost on a regular basis, requests for advice on both Cryptic and general Masonic law from the membership and from Committee Chairmen, and we must emphasize that these opinions are unofficial and gratuitous, as they were not solicited by or through the Grand Master who alone functionally enjoys the prerogative of seeking counsel from the Judge Advocate.

When we receive calls from the Companions requesting legal opinions upon matters of Cryptic law, we prefer to respond to these questions, both as a courtesy to the Companions and as a matter of Masonic education, but it is clearly to be understood that these opinions do not carry the sanction of the Grand Council, and that only the Grand Master may, with any degree of authority, advise the Companions on Cryptic law.

As we have iterated in past years, the proper procedure to secure a formal opinion is to pose the question in writing to the Grand Master. If he deems it appropriate, he may seek our counsel, and we may be requested to issue either a formal, written opinion or an informal opinion. It should be understood that the Grand Master is the primary source of all Cryptic legal authority in this Grand jurisdiction and while the Grand Council itself is not in session. Where an issue involves civil law, of course, one must retain private counsel.

Most Illustrious Grand Master, we have enjoyed working with and serving you, the Grand Council, and all the Companions this year. We also extend our appreciation to our Grand Recorder and to his Office for the input, support, and assistance, he gives, and we respectfully move that our report be entered into the proceedings of this Assembly.

PROPOSED AMENDMENTS

Section 8 of the Constitution provides that a proposition to amend the Constitution may be adopted if submitted in writing at one Annual Assembly, laid-over to the next for consideration, and then consented to by a two-thirds majority vote of the Members present; the amendment, however, may be adopted at the Annual Assembly at which it was presented, if by a unanimous vote.

Section 58 of the General Regulations provides that the General Regulations may be amended by a two-thirds vote of the Members present at any Annual Assembly.

For the purposes of clarity, the provision, if and when adopted, will read as follows:

(a) The officers of this Grand Council, excepting the Grand Chaplains, Grand Lecturer, District Deputies Grand Master, Grand Fraternal Correspondent, Judge Advocate, Grand Historian, Grand Musician, and Grand Sentinel shall be elected

at the Annual Assembly by ballot, and by a majority of the votes cast.

The following amendment to the General Regulations of the Grand Council of Cryptic Masons of the State of New York, to wit: Article I., (THE GRAND COUNCIL), Section 6, (GRAND MASTER), an amendment to subsection (l) thereof, is hereby proposed:

(1) To appoint Representatives of this Grand Council near other Grand Councils, and to receive and accredit Past Illustrious Masters as Representatives of such other Grand Councils near this Grand Council or demand their resignation; provided, however, that no Companion shall be accredited as Representative of more than one Grand Council at the same time, nor hold elected or appointive Grand Council office. Any Grand Representative to this Grand Council who shall fail, without valid excuse, to attend, or make a report in writing, at two out of three consecutive Annual Assemblies of this Grand Council shall be considered as to have offered to resign resigning his position as such Grand Representative, and the Grand Master is authorized empowered to accept such offer of resignation, or not, in his sole discretion, and if accepted to recommend to the Grand Council from which the Grand Representative received his commission, the name of some other Companion to fill the vacancy thus Should the Grand Master's request to a Grand Council for the appointment of a Grand Representative near the Grand Council of New York not be effected within six (6) months after the request has been made, the Grand Master shall be empowered, in his sole discretion, to withdraw such request, through notice from the Grand Recorder and to recommend the Companion for appointment to another Grand Council. CONCORDANT BODIES AND YOUTH COMMITTEE 2013-14 ANNUAL REPORT

Most Worshipful Grand Master, Most Illustrious Grand Master, Past Most Illustrious Grand Masters, Distinguished East, Grand Line Officers, and Companions All. This is the Annual Report of the Grand Council's Concordant Bodies and Youth Committee for the 2013-2014 Cryptic Year.

Concordant Bodies

Upon appointment by the M. W. James E. Sullivan, Grand Master of Masons in the State of New York the Concordant Bodies Working Committee consisting of <u>Symbolic Lodge</u>: R. W. William (Bill) J. Thomas, Deputy Grand Master of the Grand Lodge of NY(Chairman), Eric J. Benson (Secretary); <u>Cryptic Rite</u>: R. I. Curtis A. Banks, M. I. Rev. Charles M. Roberts; <u>Commandery/Knights Templar</u>: SK Stenrick B. Adams, SK W. Bruce Renner; <u>Royal Arch Masons</u>: M. E. Richard J. Kessler, R. E. Bruce Testut; <u>Scottish Rite</u>: Richard J. Powell, James D. Swan, Jr. and Ill. Stephen R. Whittaker, The working group did convene twice this past Cryptic year.

The Concordant Body Working Group did not meet during the COD Session in 2013. Our first meeting for this year was held at the Grand Chapter Royal Arch Masonry on Thursday, March 6, 2014. Agenda items for this meeting were: Remember the Blue Lodge Program; State-Wide Calendar issues and conflicts; the MORI System and access for Concordant Bodies (Mark Menard). It was also mentioned that Grand Commandery is part of the York Rite Information System (YRIS) and that the other York Rite Bodies of NY could join with this program too. Question is there a way to interface MORI with YRIS or vice a versa for sharing data? Not at the present time. Finally we discussed recommendations for the future of our Concordant Bodies Working Group.

The Concordant Bodies Committee has been reorganized under the new leadership of our Grand Master William J. Thomas with its membership back to being the Presiding Officer and Deputy of the Masonic Groups in New York State with the R. W. Deputy Grand Master of Grand Lodge of New York chairing the Committee and providing the agenda. The meetings of this committee will provide a general round table opportunity for discussions of mutual interest, and that they are closed and in executive session, except for discussions of the Remember The Blue Lodge Program. Membership is all ex officio, and will change with the annual meetings of the various bodies, except for COD which changes ad hoc. Members of this committee will have one vote at the Grand Lodge Annual Communications. We did convene under this new structure at the New York Council of Deliberation on Friday afternoon, July 25, 2014 under the leadership of R. W. Jeffrey Williamson, Deputy Grand Master of the Grand Lodge of New York. After brief introductions by the membership of this reorganized committee, M. W. Grand Master Thomas welcome all present and gave a brief history on the role of this committee in the past and then turned over the committee to Deputy Grand Master Williamson for addressing the further agenda items. M. I. Leonard Mason was excused from this meeting and representing our Grand Council was R. I. Harley DeShane, Deputy Grand Master. In the future the Committee membership will change based on the change in leadership for the bodies throughout the year. But it will always be the Presiding Officer and Deputy.

The Committee addressed the following agenda items: Educational Assistance Program Scholarship presentations. Deputy Grand Master Williamson encouraged all York Rite & Scottish Rite bodies to participate in these presentations throughout the state for presenting our awards it shows a united front in New York. Bodies not participating at present to look to see how they can. We then addressed the upcoming calendar dates for Receptions and Grand Lodge Apron presentation and other events from July 2014 through October 2016. All bodies were to establish links to the updated Website of Grand Lodge and promote these dates and hopefully this will produce less conflicts between events. These events now scheduled will take precedence for attendance of Presiding Officers of Grand Lodge and other Bodies in NY. Calendar interfacing between the bodies must be ongoing throughout our Masonic life in NY. We discussed the availability of the York Rite Informational System (YRIS) to the other York Rite Bodies. Grand Chapter has agreed to participate in YRIS. What about Grand Council? Scottish Rite has their own system in place. Questions raised: Interface of YRIS or MDS with MORI, How do we get needed access to demits, NPDs, suspensions so we can all update our membership rosters for our respective bodies. At present we get suspensions after a trial commission has reported from Grand Lodge but nothing else. It is critical that Grand Lodge provide a means to receive this data in order for us to operate efficiently and reduce costs. Grand Master Thomas is to pursue this item of how this information can be shared with duly authorized personnel of our bodies with the understanding that it is kept private and not to be shared with anyone. Deputy Grand Master Williamson

then addressed the issue of "How do we communicate?" He shared about present electronic ways but also stressed the need of the personal touch and that we as Presiding Officers must encourage respect and dialogue, exchange of ideas and provide whatever appropriate means to help enhance communications for all of our brothers Empire State Mason Magazine; Athol; etc were highlighted. We must work cooperatively and with the knowledge that Grand Lodge through our present Grand Master is encouraging the theme of "TEAM = Together Everyone Achieves More." Better visibility between Grand Lodge and the Concordant Bodies and vice a versa must be coordinated and complementary.

Finally, our meeting concluded with a update on the Remember The Blue Lodge Program by R. W. George Emmons, Grand Marshal of Grand Lodge of NY who is the Coordinator of this program. We have awarded 201 since the inception of the program {York Rite has 114 and Scottish Rite has 87} and additional 254 Bars have been awarded since 2007. The present year had 29 awards [17 for York Rite and 12 for Scottish Rite] But we can do better-we must do better! We have enough supplies yet to continue the program. Lets get out there and promote this program. Our next meeting is schedule for March 2015 at the Grand Chapter Royal Arch Masons of NY Convocation in Albany, NY. The respective Concordant Bodies representatives are open to receiving ideas, thoughts or comments from you to present at any of the meetings of the Committee to better the advancement of Freemasonry in this state. This meeting turned out to be a very productive one for all of Freemasonry in this State.

Youth Groups

The three remaining Youth Groups in New York State: The International Order of the Rainbow for Girls, The Organization of Triangles, Inc., and The Order of DeMolay were all active this past year and represented at many Masonic functions and activities throughout the state. We regret that The Order of Constellation of Junior Stars was dissolved and no longer in the state. But the three remaining youth organizations are strong and hopefully will remain so.

The International Order of the Rainbow for Girls Grand Assembly met at the Honors Haven Resort in Ellenville, NY on April 10th - 13th, 2014 and Miss Hannah Nelson was elected Grand Worthy Advisor and her theme for the year will be "Reach Out and Spread Your Wings." Although Rainbow in New York State is actually 90 years young, they will be celebrating their 75th Anniversary of Grand Assembly at this year's Grand Assembly Sessions to be held April 23rd - 26th, 2015 at Honors Haven in Ellenville, New York. A special Diamond Jubilee Celebration is being planned for Saturday Evening, April 25, 2015.

The Organization of Triangles, Inc. Biennial Convention met at the Hudson Valley Resort and Spa in Kerhonkson, NY on October 11-13, 2013. Miss Ally Callaghan from Sunrise Triangle was elected the NY State Representative. Her theme for the year will be "For A Finer American Womanhood." The Organization of Triangles, Inc. Biennial Convention will meet at the Hudson Valley Resort and Spa in Kerhonkson, NY on October 9-11, 2015.

Starting this coming year (2015) the York Rite Bodies will initiate a new program called the Order of Deborah. This Award will be bestowed upon one deserving young lady of NY International Order of the Rainbow for Girls and one for the Organization for Triangles, Inc. The Award will comprise of a medallion to wear and an inscribed gavel. NY Grand Chapter Royal Arch Masons and NY Grand Council will each be responsible to purchase one gavel for presentation to one of the girl's organizations each year since the Grand Commandery purchases a sword for the York Tribune selected each year from NY DeMolay. We are truly excited for this new award program and we hope you will support it.

The 47th Annual Convention of the Order of DeMolay in NY State met at Utica College/Masonic Care Community, Utica, NY on August 1-3, 2014 where DeMolay C. It is your Committee's strong recommendation that as individual Masons and Companions and as a Grand Council we take serious our charge of support and encouragement of our youth organizations in this state. Companions:

The work of the <u>Ritual Committee</u> this year is the examination of the proper pronunciation of all names and places from the two Testaments of the Holy Bible that occur in our ritual. Inconsistences occur in these pronunciations. To this end the following sources have been examined to produce the most uniform spellings and pronunciations.

The Oxford Self-Pronouncing Bible of the Authorized King James Version - Grand Lodge of New York edition
Nelson's Illustrated Bible Dictionary
Holman Illustrated Bible Dictionary
Volume VII - Mackey's History of Freemasonry - Appendix - Pronouncing Dictionary for use by the Masonic Fraternity.

All these sources are in agreement on the proper pronunciation of Bible names and places occurring in our rituals. There is a uniformity in these sources that hope to overcome the individual Mason from using pronunciations that are in error that often occur. This happens when they have learned a pronunciation that is not in keeping with established rules.

The names and places from the Bible were originally written in three languages. The Old Testament, in Hebrew and Aramaic. The New Testament, in Koine Greek. It is an imposition and error to expect our companions to pronounce some names and places in the original language form. There is an accepted anglicized form that is recommended not only by Grand Lodge and Grand Council but recognized secular Bible sources as well.

A new page of corrected pronunciations will be available at The Grand Council session.



Report of the Jurisprudence Committee

June 21, 2014

Recommends the Grand Council take action on the following changes to the general Regulations of this Grand Council.

New text is underlined; deleted text is erossed out.

Article I. Section 3, (Grand Officer, How Selected), subsection (a)

Section 3 - Grand Officers, How Selected

(a) The officers of this Grand Council, with the exception of excepting the Grand Chaplains, Grand Lecturer, District Deputies Grand Master, Grand Fraternal Correspondent, Judge Advocate, Grand Historian, Grand Musician, and Grand Sentinel and Assistant to the Grand Recorder shall be elected at the Annual Assembly by ballot; and by a majority of the votes cast.

* * * * *

For the purpose of clarity, the provision, if adopted, will read as follows:

(a) The officers of this Grand Council, excepting the Grand Chaplains, Grand Lecturer, District Deputies Grand Master, Grand Fraternal Correspondent, Judge Advocate, Grand Historian, Grand Musician, and Grand Sentinel shall be elected at the Annual Assembly by ballot, and by a majority of the votes cast.

Article I, Section 6, (Grand Master) subsection (1)

(1) To appoint Representatives of this Grand Council near other Grand Councils, and to receive and accredit Past Illustrious Masters as Representatives of such other Grand Councils near this Grand Council or demand their resignation; provided, however, that no Companion shall be accredited as Representative of more than one Grand Council at the same time, nor hold elected or appointed Grand Council office. Any Grand Representative to this Grand Council who shall fail, without valid excuse, to attend, or make a report in writing, at two out of three consecutive Annual Assemblies of this Grand Council shall be considered as to have offered to resign resigning his position as such Grand Representative, and the Grand Master is authorized empowered to accept such offer of resignation, or not, in his sole discretion, and if accepted to recommend to the Grand Council from which the Grand Representative received his

commission, the name of some other Companion to fill the vacancy thus created. Should the Grand Master's request to a Grand Council for the appointment of a Grand Representative near the Grand Council of New York not be effected within six (6) months after the request has been ma

de, the Grand Master shall be empowered, in his sole discretion, to withdraw such request, through notice from the Grand Recorder and to recommend the Companion for appointment to another Grand Council. If a Grand Council shall not have responded to a request for such and appointment after the passage of one (1) year from the date upon which request therefor shall have been made, the Grand master shall, through notice from the Grand Recorder withdraw such request and may seek the appointment for the Companion from some other Grand Council.

* * * * *

For the purpose of clarity, the provision, if adopted, will read as follows:

(1) To appoint Representatives of this Grand Council near other Grand Councils, and to receive and accredit Past Illustrious Masters as Representatives of such other Grand Councils near this Grand Council or demand their resignation; provided, however, that no Companion shall be accredited as Representative of more than one Grand Council at the same time. Any Grand Representative to this Grand Council who shall fail, without valid excuse, to attend, or make a report in writing, at two out of three consecutive Annual Assemblies of this Grand Council shall be considered to have offered to resign his position as such Grand Representative, and the Grand Master is empowered to accept such offer of resignation, or not, in his sole discretion, and if accepted to recommend to the Grand Council from which the Grand Representative received his commission, the name of some other Companion to fill the vacancy thus created. Should the Grand Master's request to a Grand Council for the appointment of a Grand Representative near the Grand Council of New York not be effected within six (6) months after the request has been made, the Grand Master shall be empowered, in his sole discretion, to withdraw such request, through notice from the Grand Recorder and to recommend the Companion for appointment to another Grand Council. If a Grand Council shall not have responded to a request for such and appointment after the passage of one (1) year from the date upon which request therefor shall have been made, the Grand master shall, through notice from the Grand Recorder withdraw such request and may seek the appointment for the Companion from some other Grand Council.

Article II, Section 24 (Annual Returns), subsection (a)

(a) Each Council within this jurisdiction shall make Annual Returns to the Grand Council for the term ending June 30th of all its work to May 31st in each year on blanks forms provided by the Grand Council for that purpose, and cause the same, together with the dues of the council Grand Council and General Grand Council per capita dues to be transmitted to the Grand Recorder on or before July 10th following. A Council that fails to comply with the provisions of this Section shall not be entitled to representation at the Annual Assembly of the Grand Council nor shall any of the representatives of the

<u>Council be entitled to vote.</u> For a failure to transmit said return and to pay said dues by said date, the Council will not be allowed to vote.

* * * * *

(a) Each Council within this jurisdiction shall make Annual Returns to the Grand Council of all its work to May 31st in each year, on forms provided by the Grand Council for that purpose, and cause the same, together with Grand Council and General Grand Council *per capita* dues to be transmitted to the Grand Recorder on or before July 10th following. A Council that fails to comply with the provisions of this Section shall not be entitled to representation at the Annual Assembly of the Grand Council nor shall any of the representatives of the Council be entitled to vote.
