# MINUTES OF THE 192<sup>nd</sup> ANNUAL ASSEMBLY GRAND COUNCIL OF CRYPTIC MASONS OF THE STATE OF NEW YORK

The 192<sup>nd</sup> Annual Assembly of the Grand Council of Cryptic Masons of the State of New York was held on Friday, August 21st and Saturday, August 22nd, 2015 at the Treadway Inn, Owego, NY.

### **OPENING AND RECEPTION OF GRAND MASTER AND OFFICERS OF GRAND COUNCIL:**

A Council of Select Masters was opened by the Illustrious Master and Officers of Cayuga Council No. 90 on Friday, August 21<sup>st</sup> at 7:45 PM. The Officers of Grand Council were received into the Council and formed lines for the reception of the Most Illustrious Harley R. DeShane, Grand Master. MIGM DeShane was greeted with Private Grand Honors he ordered all Grand Line Officers to assumed their stations and places in the Council. Then MIGM DeShane spoke on the gavel being used for this Assembly work, It came from the Louisiana Grand Council. The Most Illustrious Grand Master invited RI Harvey Eysman to the East and presented him with his Grand Judge Advocate apron. Grand Honors were accorded him and he took his office location. M:I:G:M: Harley R. DeShane then called the Grand Council to order.

**ENTERED**: The Deputy Grand Marshal of Grand Lodge entered the Council and announced that R : W : Jeffery Williamson, Deputy Grand Master was about to enter... he entered and was greeted by M : I : G : M : Harley R. DeShane and was given Grand Honors and was seated in the East. The Grand Marshal entered the Council and announced that the Most Worshipful Grand Master William J. Thomas, Grand Master of the Grand Lodge of New York State was about to enter... he entered the Council was greeted in the East by M : I : G : M : Harley R. DeShane and was given Grand Honors and was seated in the East.

### **OPENING OF THE ANNUAL ASSEMBLY OF GRAND COUNCIL:**

A constitutional quorum of constituent Councils was determined to be present, and the Grand Master DeShane declared the  $192^{nd}$  Annual Assembly of the Grand Council of Cryptic Masons of the State of New York opened in ample form. In accordance with New York State Fire Laws, he then advised the Companions of the exits in case of emergency. The M.I.G.M.Harley DeShane Advised all Companions present that they must register with the Credentials & Registration Committee in order to vote...he advised all present that the Registration desk was located in the main lobby. M.I.G.M.DeShane then had the names of delinquent Councils not entitled to vote at the 192nd Annual Assembly. Union Council No. 2 failed to submit its Annual Per Capita payment.

### **COMMITTEE APPOINTMENTS:**

The Grand Master then appointed a Credentials Committee, consisting of M.: I.: David Raymond, Chairman RI James Zearfoss, RI James Hemstrought and Comp. Alex Turck.

The Grand Master appointed a Committee to reply to the Grand Master's Address, consisting of M.I..., Chairman

### **RESOLUTIONS:**

- 1] A Motion that the minutes of the 191<sup>st</sup> Annual Assembly as distributed in the packet and will be printed on the 2014-15 Proceedings CD be approved by MI Paul B. Matthews.
- 2] A Motion that all Companion Select Masters in good standing be invited to remain as visitors to this Annual Assembly, except at such time as provided by the Constitutions by MI Vic Versace.
- 3] A Motion that the Annual Reports of the Elected Grand Line Officers, from Grand Principal Conductor of the Work to the Grand Judge Advocate inclusive, as are printed or will be published on the 2014-15 Proceedings CD, be approved by MI E. William Whittaker.
- 4] A motion that the Election of Officers be the Order of Business at 1:45 PM on Saturday, August 22, 2015 and that nominating speeches be limited to three [3] minutes and that seconding speeches to two [2] minutes by MI Donald Harrison.



5] A Motion that our visiting Grand Masters and Past Grand Masters who are not already Honorary Members of this Grand Council be made so by MI Frank Karwowski.

All Motions were made, seconded and passed unanimously.

Jurisprudence and By-Laws Review Committee

### **CONDITION AND EXTENSION OF THE RITE REPORT:**

The report of the Committee on the Condition and Extension of the Rite was given by RI Curtis Banks. He stated only a handful of DDGM gave reports and recommendations. Opening and Closing Ritual needs to be worked on by all Officers of Councils to become more proficient from memory. Correct recitation of the ritual is critical for us all. RI Banks spoke to the availability of the Historical Proceedings on CD for a nominal cost of \$50.00 for three copies for a Council. At present Master Copies given to former Grand Recorder Powley have not been found as of yet but RI Banks assured all that he has the original Masters that he did to secure new ones if these are lost. MI Roberts will be looking for them once he gets all the records of the Grand Recorder's Office. Motion to approve the report and spread it full upon the minutes of this Annual Assembly, seconded and passed unanimously.

# REPORT OF THE COMMITTEE ON MASONIC EDUCATION, MEMBERSHIP AND PUBLIC RELATIONS:

The report was given by R. I. Curtis Banks was not able to meet throughout the year and has nothing to report collectively. He advised all that Masonic Education is at the top tier request for Companions who are new to our Order of 5 years or less. He suggested that Grand Lecturer and AGLs become a part of this Committee to work on Ritual and Education so that they go hand-in-hand to building our Councils and the Officers thereof. On motion to approved the Report and spread full upon the minutes of this Annual Assembly, seconded and passed unanimously.

### REPORT OF JURISPRUDENCE AND BY-LAWS REVIEW COMMITTE

MI E. William Whittaker reported on behalf of the Committee. The Committee recommends the Grand Council approve the By-Law Changes for the following Councils: Hornellsville Council No. 35, Adoniram Council No. 36 and St. George's Counmoil No.74. On motion duly seconded the Grand Council approved the By-Law Changes unanimously.

### GRAND LECTURER'S REPORT AND RECOGNITION OF ASSISTANT GRAND LECTURERS:

The Grand Lecturer's Report was given by R. I. Stewart W. Card. A motion was made duly seconded and passed unanimously to accept the report and spread it full upon the minutes of this Annual Assembly. No request for modifications of our present ritual have been received this year. Grand Lecturer Conventions held in all Districts except one with reviewing the degree of Royal Master. Host Councils had increased attendance others of the District not so. Net year the Ritual will center on Select Master Mason Degree and other growth and historical elements of the Cryptic Rite. Ritual presentation has improved but still more improvement is needed Our Ritual is what distinguishes us from all other organizations we must take it serious and do wherever possible from memory and at our best, for our Candidates

The Assistant Grand Lecturers present were recognized. They were each personal thanked by Most Illustrious Grand Master DeShane for their work this past Cryptic Year, and Given Grand Honors.

On motion by RI Card that all submitted AGL reports be accepted, motion was duly seconded and carried unanimously.

### REPORT ON THE WEB SITE:

A report on the Web Site was given by R : I : I. John Gallant, Webmaster, a motion was made, seconded and passed unanimously to accept the report and spread upon the minutes.



### NORTHEAST CRYPTIC FESTIVAL REPORT:

RI Steve Koch presented the report and basically stated the printed report captures the essence of the Festival and the activity which took placed. He asked if there were any questions. None were raised. On motion to accept the report, duly seconded and approved unanimously. He highlighted that Grand Council of New York would be hosting the Tri-State Festival this coming year in 2016.

### **CONCORDANT BODIES AND YOUTH COMMITTEE**

MI Roberts reported for the Committee. It has been a very active year for the Concordant Bodies and Youth Committee. He summarized the written report by highlighting items written therein. On motion to accept written report and spread it full upon the minutes of this Annual Assembly, duly seconded and approved unanimously.

### NEWSLETTER EDITOR COMMITTEE

RI Koch stated that nothing really took place with the Newsletter this year. On motion to receive the written report, duly seconded and unanimously approved. A question was raised whether the Newsletter is still viable with us using the website to promote more. It is if we intentionally submit articles and advertise ourselves. But maybe we need to evaluate its use future use or its purpose.

### REPORT OF THE GRAND HISTORIAN:

No Report was given in written or oral form.

### REPORT OF THE GRAND FRATERNAL CORRESPONDENT:

The report of M : I : Paul Matthews stated that sadly there is none annual report due to the loss of our Grand Recorder, no input from sister jurisdictions or Grand Representatives except for one. Maybe we will have a fuller report next year.

### **LONG RANGE PLANNING REPORT:**

No report was given.

### REPORT BY THE DEPUTY GRAND MASTER:

RI Charles V. Bunton gave his report. Moved, seconded and approved.

### **REPORT OF THE GRAND TRUSTEES:**

The report was presented by M.I..& Rev. Charles M. Roberts he gave an oral overview of the Trustee Report. He was grateful we only had to take out only \$5,000 to meet operational expenses. He stated that this year 2015-16 the Per Capita Tax increase that was approve would take effect upon the mailing of the Annual Returns. This hopefully will keep us solvent for awhile and we will not need to take resources out of the Permanent Fund. He moved the report printed in the handed out packet be approved and spread upon the minutes of this Annual Assembly the motion was seconded and passed unanimously.

### **REPORT OF THE GRAND TREASURER:**

An oral report was given by M.I.Don Harrison on the budget and how we faired this Cryptic year. He mentioned we had to use funds from the Permanent Fund in order to balance our Budget. We withdrew \$5,000.00. The full report was printed in the hand out packet. M.I.D Harrison made a motion that the reports be accepted and spread upon the minutes as printed in the hand out, was seconded and passed unanimously. M.I.D Harrison spoke on the Escrow Fund and the proposed Operating Budget for 2015-2016. Please see the attached financial statements concerning the Grand Council's Finances. Grand Council on motion by MI Harrison approved the proposed Budget for 2015-2016. Treasurer reported that he would have to make a slight correction to the Budget submitted but will have revised Budget to the Grand Recorder for anyone's perusal.

### **AUDIT/FINANCIAL REVIEW COMMITTEE**

RI George Emmons addressed the Grand Council concerning the Grand Treasurer's Financial Records and that of the Grand Recorder. With the untimely death of our Grand Recorder, Ted Powley, he stated that unequivocally it had no noticeable impact on the financial records. They were all found to be in good order and

Our DDGM's have all reported in a timely manner in regards to how each Council fairs not only with its ritual but to the point(s) of what YOU the companions would like. Currently the reports of each DDGM is included for you review but overall the DDGM's have made a somewhat unilateral assessment of the councils which is that our Council Officers are making a sincere effort in using outside resources to bring education of the Rite into the Councils and that we as a Grand Council must hear this. # Report of the District Deputy Grand Master of the First Cryptic District, R:.I:. R. Conrad Johnson

Firstly I would like to express my deepest gratitude to the Grand Line members, past and present, for my appointment as District Deputy Grand Master of the Grand Council of Cryptic Masons of the State of New York. It has been a pleasure to work with the Cryptic team this year and I look forward to another successful year.

Here is a summary of observations over the last year I have regarding the Councils in the First District, in alphabetical order. In general, the Councils are vibrant and interested in prospering, each with senior members of the Craft guiding and mentoring the more junior Companions. In general also, I observed some strong ritual work — accurate memorization and emphatic delivery, and some work that was neither and could benefit from additional guidance.

Like many Masonic bodies I have visited in various District Deputy capacities (Lodges, Chapters, and Councils), there can be a broad range of what is acceptable or standard in terms of books and records. The result is that each Council has its own framework and expectations.

Adelphic Council No. 7 meets the fourth Wednesday of October, January, March, and May. I visited on October 28<sup>th</sup>, 2015. The Officers performed well with a combination of general command of the material and some reading or reference to the ritual during the opening. Right Eminent Past Grand Commander George Harrison is the Recorder, and the books and records are immaculate and very well organized.

This year Adelphic Council hosted the Grand Lecturers Convention on March 23<sup>rd</sup>, 2016, and both the Royal Master and Select Master were performed that night. The Officers of Adelphic performed many of the roles, with the assist from others in the District, notably Columbian Council. I had the pleasure and privilege to take the part of Hiram Abif in the Royal Master, and again am struck with the profound beauty and importance of this work.

Adelphic Council has a number of York Right luminaries involved, including REPGC Don Berry, incoming Grand Commander Ritchie Kerimoglu, and Grand Captain of the Host Paul Huck. Adelphic Council is an exceptional Council.

Adoniram Council No. 36 meets on the fourth Thursday of September, November, February, April, and June. As I reported last year the Council is in rebuilding mode and working to fill the chairs with regular officers and bring in new members. A group of dauntless Masons, the Council is led by several Companions of the Council including R:.I:. Ari Chisin, James Reichman, John McKoy, and I:. Joe Savaglio. I met with the Council on January 14<sup>th</sup>, 2016.

I also attended a special meeting held April 14<sup>th</sup> for the purpose of holding Annual Elections and Installations.



The condition of their books and records and paraphernalia is fair to very good. Over the past two years this Council has made huge strides, but they need to continue bringing new members in and creating a support structure with the other York Rite bodies.

Columbian Council No.1 meets on the second Wednesday of January, February, and March. I attended both January and February meetings, but business travel in March precluded some Masonic activity for me, including the conferral of the Super Excellent Master Degree in March. Ritual work in general at Columbian is quite excellent, with most if not all of the work memorized and delivered with authority and passion. All the seats of the Line are committed and it is unusual for any position not to have its elected or appointed Officer attendant. Fellowship follows every meeting with a dinner, with opportunity to engage in educational discussion. Generally the equipment is available and in good shape, but the Charter is quite old and battered and should be replaced.

Columbian Council also has the unique distinction that it performs the Most Excellent Master degree each year, which usually hosts Companions from the First District as well as visitors.

Flatbush Council No. 80 meets the fourth Tuesday, September through June. However, Flatbush Council meets on the same night as its Commandery of Knights Templar, so more focus may be given on the night of the meeting to one or the other, depending on the work of the evening (for example conferring the Royal Master versus the Order of Malta). I visited Flatbush on March 22<sup>nd</sup>, 2016. Again, a very strong culture and a close-knit group of individuals working to enrich both Flatbush Council and Bay Ridge Commandery. Several senior members of the York Rite Grand Bodies (including R:.I:. Curtis Banks) are involved in this Council as well, contributing to the stability of the Council. The junior Companions and Officers generally speaking are quite solid with the ritual work and are passionate about their involvement. You really get the sense that the line works hard to be professional in their roles.

The books and records need to be reviewed in depth this year, since many of them were not available at the visit.

North Shore Council No. 88 meets the fourth Monday in September, November, January, March, and June. I visited North Shore on November 23<sup>rd</sup>, 2015. We were warmly received and dined prior to the meeting with the I:. Steven Rubenstein and several of the Companions. During the opening, there was a combination of Companions who had some command of the material while others resorted to reading. However I appreciate the strong culture and close fellowship of the Companions and there is great history to the Council and the other York Rite bodies associated with this location. Also, the Companions and Sir Knights in the other York Rite bodies in the area are quite involved.

North Shore has a core group of stalwarts, and the condition of their books and records is fair to good, and paraphernalia is excellent, however the evening of the inspection neither the Treasurer nor Trustee was present to walk me through the financials of the Council.



**Suffolk Council No. 76** meets on the second Friday of September through June (except April). My visit was scheduled Friday the 13<sup>th</sup> in 2015. This Council is a pleasure to visit – I was quite warmly greeted and quite a few Companions showed up for both the visit as well as the dinner beforehand. The Council finished the evening by presenting a custom ordered cake!

Suffolk also has solid books and records as well as equipment, and a growing membership.

In summary, the books and records as well as the paraphernalia are in good condition with some followups to be performed. The ritual work of the First District is quite solid, with exceptional standouts as well as some room for improvement. My perception is that all Companions are interested in improving their work as well as open for additional educational opportunities.

I look forward to visiting all the Councils again this year and continuing my support for the District.

## District Deputy Grand Master 6th Cryptic District Report 2015-2016

### Rotica Council No. 12:

This Council performs the opening and closing ritual very well and can confer the Degrees without assistance. The Council is financially sound and has new members progressing through the chairs. Membership decreased slightly this year.

### Central City Council No. 13:

This Council performs the opening and closing ritual very well and can confer the Degrees without assistance. They conferred the Royal Master Degree October 14, 2015 on five Companions and the Select Master Degree March 9, 2016 on four Companions. This Council is financially sound and has new members progressing through the chairs.

### King Hiram Council No. 18:

The condition of the Masonic Temple in Port Byron has required a change of location to the Waterloo Masonic Lodge. This Council has weathered a very difficult period and is in dire need of new members with a current membership of 11. This Council cannot open or confer the Degrees without assistance from other Councils. This Council has minimum finances available.

### Fulton Council No. 50:

This Council performs the opening and closing ritual well and can confer the Degrees without assistance. They did not confer the degrees this Cryptic Year. This Council is functional but needs some new members. This Council has minimum finances available.

### King David Council No. 97:

This Council performs the opening and closing ritual well and can confer the Degrees without assistance. They did not confer the degrees this Cryptic year. This Council is functional, does have some younger members coming up thru the line but needs more new members. This Council has minimum finances available.

### In summary:

On October 22, 2015 was the 6th Cryptic District Grand Lecturer's Convention at king David Council No. 97 in Dexter. This was attended by King David No. 97, Central City No. 25 and Rotica No. 12. The 6<sup>th</sup> Cryptic District Councils will remain dependant on the long term health of the Chapters they have to draw members from.

There are only Three Councils in the  $9^{th}$ , and I was serving as AGL in my first year as a past I.M. because the talent pool had so many R.I. salready. We came up with a 'plan B' adopting what I called AGL-By-Committee. I urged the three I.M. s to make themselves available to R.I. Stuart Card and to arrange the Grand Lecturer's Convention. Kudos to I. Gene Olofson of Dunkirk #25 for hosting it.

Dunkirk #25 is continuing to maintain at least the status quo of opening and closing properly, albeit with a good deal of dependency on the Monitor. What they need is new Master Masons coming into their local lodges that are then encouraged to take the York Rite path to further light. It looks like that will be the case in a short while, in fact. If #25 can persist as the furthest outpost of Royal and Select Masters in Western-most New York while more Royal Arch Masons are exalted, their exertions will be rewarded. I visited them twice, including the GLC.

Hamburg Council #91 continues to enjoy success, meantime. The home council of M∴W∴ Grand Master Jeffery M. Williamson celebrated the rededication of their Secret Vault and the recovery of their original warrant, which had been lost. I find that ceremony to be an altogether satisfying masonic tour-de-force. Along with this event, I attended their two degrees, and their installation of officers. While their principal officers are past I∴M∴s, they have a strong group of new companions beginning their journeys to the East in CC, Marshall, Steward and Sentinel. Soon enough there will even be new talent in the pool for the District offices.

Buffalo-Keystone Council #17 has been doing what needed to be done, greeting leaders and influencers as new members, who in turn have brought along others curious to learn what makes them so passionate for Cryptic Masonry. I.: Steve Eisenhower has a strong lineup of companions new to the Secret Vault but not new to the Craft. # Grand Council of Cryptic Masons of the State of New York Grand Lecturer's Report for 2015 – 2016

Conventions were held in 5 of 7 Districts. All host Councils turned out a good crowd of their own members (sadly turnout from Councils other than hosts was low) and showed knowledge of opening and closing, *either* without errors *or* without using a book.

The Convention focus was the Select Master degree ritual, including complex floor work and opportunities for dramatic performance. We also discussed the history and symbolism of the degree, as well as the effect it should have not only on the candidates but also on the observers and participants. In the words of my favorite author (whom I recommend to you all), the late Robert Anton Wilson, "A true initiation never ends."

If I am re-appointed, the work of the Conventions in the coming year will be the degree of Super Excellent Master plus any other ritual topics requested by the Companions of the District. With your help, we will again try to schedule these early in the year to maximize their value to the Councils. My job and that of all the Assistant Grand Lecturers is to *help* the Councils in the primary function of Cryptic Masonry: by performing ritual competently and with feeling, to transform the hearts and minds of Companions, making us all ever better ashlars.

In the coming year, Grand Council will work, through our District officers, with the Councils, to offer festivals in venues that reinforce the emotional impact of the degrees. We still hope to confer the Select Master in actual caverns or tunnels: the Lockport Hydraulic Tunnel could work for the western part of the state; we need help identifying suitable locations, considering accessibility, safety and cost, in the east and downstate.

Our ritual is what distinguishes us from all other organizations. It is the means by which we transmit the unique message of Cryptic Masonry. It is the structure into which we pour our energies to provide the transformative experiences our ceremonies should be, that they *must* be to have any value. Whatever else you do in Cryptic Masonry, we ask you to remember the central and essential role of our ritual, and to give it the respect, attention and effort it deserves. This starts with the opening: experienced members need to exemplify this and train our eager newer members to do it in a manner that prayerfully attunes the minds of all Companions present, preparing them to perform effectively and benefit abundantly from the Masonic work of our Assemblies.

I had the honor to travel the district with R.I. Mike Quigley, DDGM for the 2nd Cryptic District. We have enjoyed working together these past few years. I have seen some improvements in the 2nd Cryptic District with our 4 Councils. I have broken down each Council below.

#### Union #2

I had an opportunity to meet with these Companions outside of Council as well as during meetings. Some of their members are involved in the other York Rite Bodies as well as Eastern Star. This is a small Council but will soon be growing thanks to the influx of Companions from Royal Arch. They are still using the books for opening and closing. However, I feel if they continue to build their membership through the Royal Arch and the Lodges that their ritual will get better. I don't think they can do any of the Council Degrees on their own yet but I would like to see them take part and assist other Councils.

#### King Solomon #31

On August 21 & 22, 2015, I attended Grand Council in Owego. I marched in as a member of Grand Commandery and attended every session of Grand Council and the break out meetings as well, particularly the AGL's meeting with the Grand Lecturer.

On September 9, 2015, I accompanied the District Deputy Grand Illustrious Master Dennis Davis on his Official Visit to Central City Council #13, Liverpool-Syracuse. Central City is doing very well. They have a strong line of leadership. They are active in the Cryptic District and at the Grand Council level. Central City confers both the Royal Master and Select Master Degrees with only minimal assistance from outside this Council. On October 19, 2015, I accompanied the District Deputy Grand Illustrious Master on his official visit to Rotica Council #12. Rotica Council is strong and doing very good ritual work. They have a strong leadership and a line of officers coming thru. They are doing both Royal and Select Master degrees at Rotica almost every year and Rotica members assist in almost all the degrees in this district.

On October 22, 2015, I attended the 6th. Cryptic District's Grand Lecturer's convention with our Grand Lecturer and our District Deputy Grand Illustrious Master at King David Chapter #97 in Dexter, NY. The insights of the Grand Lecturer into the Select Master degree was the message for the evening and it was again, similar to his insights into the Royal Master Degree the previous year, an outstanding and insightful program. This visit also served as the official visit of the DDGIM. The ritual work at King David is good but also could improve.

#### ASSISTANT GRAND LECTURER'S REPORT FOR THE 8<sup>TH</sup> CRYPTIC DISTRICT 2015-2016

In reviewing the positive and negative attributes of the Councils in the 8<sup>th</sup> Cryptic District, there are a number of similarities shared among them.

The interest and participation in each Council is indeed heartening, although a mitigating factor is membership. With overall membership declining throughout the District as a function of the attrition brought about by age, relocation, declining health issues and death. A number of the Councils have found themselves hard-pressed to have enough Officers to open.

One of the ramifications of this predicament is difficulty mastering ritual----if a Councils generally hold one meeting each month. Therefore, if a Council is unable to open frequently, and many do not, months can elapse with no meetings taking place. Without this opportunity to engage in and thereby enhance ritual proficiency among the Officers, the problems in opening and closing, which are inherent components of ritual, are thereby often exacerbated.

In an attempt to compensate for this quandary, most (if not all, to an extent) of the Councils do rely upon Ritual Books to sustain themselves in being able to conduct their meetings.

The desire to conduct meetings is clearly evident throughout the District, yet the lack of membership and sporadic meetings throughout the year are most definitely impediments to continuity.

During my visits to each of the Councils in the District, I was impressed with the tenacity of the memberships in attempting to be able to successfully conduct their meetings despite the pitfalls which face them. In each case, the Officers "went that extra mile" to perform in an adequate manner. I have to commend them in demonstrating a Yeoman's job in the efforts they have demonstrated.

To elucidate each Council current state in specifics is difficult at best, as they each seem to hare a common yet prevalent problems, as alluded earlier in this report. However, I will attempt to describe each individually in the following report:

- 1) Of the councils in the 8<sup>th</sup> Cryptic District, Doric Council, # 19 is for the most part, able to open and close and is fairly fluent in its ritual. There are occasions when they do not have enough Officers to pen, but this malady is generally adequately rectified through assistance of occasional "sideliners." Additionally, this Council is able to perform Degree work and is thereby able to sustain itself for the present.
- 2) Unfortunately, Palmyra Council, # 26 found itself in difficulty as a result of declining membership. A recent effort to recruit new Companions resulted in one member, who shortly after, passed away. As a result of that unfortunate incident, coupled with an extended period of struggling, their Council has since merged with Doric Council, # 19.



- 3) Hornellsville Council, # 35 has, this year, been able to fill its Officer line up, but attendance, a predominant problem across the District, places this Council in peril by limiting the opportunity to open and thereby conduct meetings. Ritual books are used to an extent.
- 4) Skoi Yase Council # 75 is able to open and conduct meetings, but like other Councils in the District, relies upon the assistance of Ritual Books. They are able to conduct Degree work, as well as to sustain themselves at present, but attendance is an ever present ye not uncommon dilemma.
- 5) Nun-Da-Wa-Ga Council, # 92 is able to open for the most part without the aid of Ritual Books.

  Most scheduled meetings have been held. Ritual work is successfully conducted. This Council is self-sufficient and able to maintain itself.

Over all, confronted with the foibles facing most fraternal bodies in recent times, the Councils of the 8<sup>th</sup> Cryptic District appear to be able to carry out the work necessary for sustainability, albeit with assistance of Ritual Books and some combined efforts and periodic substitution of Officers.

## The Annual Report of the Grand Recorder 2015-2016

Acting Most Illustrious Grand Master Hutchurson, my fellow Grand Line Officers, Past Most Illustrious Grand Masters, and Companions all:

Let me state unequivocally that this year has been a very busy year in the Office of the Grand Recorder. First, I started out immediately trying to address the confusion of files on the Grand Council Computer. Unfortunately the hard drive files were backed up twice onto the hard drive. There were numerous duplicate and triplicate files. I had to sort through three layers to reach the true files. Many files were partial, corrupt and unnecessary. After cleaning all those I had to open up all files that were in pdf format with no names only numbers and no master file was found on the computer to coordinate a numeric file to a name file. Many long and tedious hours were spent to clean up the files into name files. This task alone was from September to late January of this year. The computer is much more efficient and useable but more detailing to files need to be accomplish to tweak it to perfection which I hope to address this year.

I than began to address the non-assigned Grand Council numbers for members over the last several years, with the assistance of Council Recorders and a more organized computer, I was able to locate membership files, consolidate them and assign all Grand Council numbers to members and informed all Recorders of them this past Spring. The only ones to be assigned are the 2015-16 Cryptic Year members which already have been entered into the data base. Unfortunately I am waiting on two back years of new members names from Flatbush Council so that the Grand Council numbers assigned stay properly sequenced. I wish to thank the previous Grand Recorders for their assistance in locating and tracking the needed information to accomplish this enormous task (MI Paul Matthews, MI Joe Pozefsky and MI Victor Versace). Thank you to the Recorders of the local Councils for their patience and help. Many phone calls and emails were done to accomplish this task this year.

Finally, I would like to thank my son Josh for his wealth of knowledge on computer programming and his patience with me with my many questions in assisting to straighten out the mess with our Grand Council computer.

With the untimely resignation of our Most Illustrious Grand Master Charles Bunton in February, I had to shift gears to bring up to speed out Deputy Grand Master and address the effects of this on the Grand Council. As most of you know, MI Harrison and I had tried to resolve the Marriott Hotel in Islandia, NY for this Annual Assembly to no avail. We are still in litigation over the signed agreements by Companion Bunton. Hopeful we can resolve this issue very soon. We did have to retain a Long Island attorney to assist us in this legal matter. I would like to go on record to inform all present Grand Line Officers and future ones too, that, they nor their Councils are able to sign any legal agreements binding this Grand Council to anything. The Officers who have this authority are only the Grand Recorder and/or Grand Treasurer with the consent of the Most Illustrious Grand Master. This year with a resignation and the Marriott debacle both the Grand Treasurer and the Grand Recorder have spent many burdensome and wasteful hours.

The financial health of this Grand Council is now on a better footing with the implementation of the new increase in Per Capita this Cryptic year. Though we ended in the negative this year due to unforeseen circumstances, the future looks to be in the positive. But we need to keep vigilant with expenses. I hope to save some money for the Grand Council in the Grand Recorder's office as we begin the scanning process of old records to cut back on storage fees. We only have one file cabinet with membership cards, several cartons and supplies being stored. I have the supplies stored at present at my home and church office until such time we need to move them. The scanning of the materials in the one file cabinet with old 3x5 membership cards will be tackled this coming year. MI Mason has volunteered to assist in this project.



Sorry, Len we were not able to begin it this Cryptic year. I hope to address the numerous scanning of records stored in boxes too. I plan to be a faithful steward of the financial resources entrusted to the Grand Recorder's Office for the operations of this Grand Council.

All financial obligations of this Grand Council for this Cryptic year have been paid in a timely manner including one youcher for a Grand Line Officer that was overlooked for the 2014-2015 Cryptic year. The finances of the Grand Recorder's Office are as follows:

I thank the former Grand Recorders for their kind assistance and counsel while learning all the details of this Office. I hope I have done it justice.

The financial market this year has shown more stabilization and less fluctuation than in recent years. We had an increase of \$6,331.46 in gains/ dividends in the Permanent Fund. But due to a decrease in share value with American Funds (down \$0.79) per share and Putnam Funds (down \$0.46) per share from last year and a withdrawal of \$5,000.00 from the Putnam Fund we ended the year with a net value decline of \$5,766.18 since our last Annual Assembly.

The Trustees also suggest that the constitution be changed to enable the Trustees to work within the normal parameters of a Trustee with the abilities to assist the Grand Council and the beneficiaries of these funds (membership) or in a manner in which men in ordinary, prudence, discretion and judgement would act in the management of their own affairs.

Finally, we remind the Grand Recorder that the current Grand Council Officers' & Past Grand Master jewel/apron forms must be signed and be current each year for such current and past Officers. We encourage all Present and Past Grand Officers to have a rider on your homeowner's insurance to cover the cost of replacement of the property held in your trust (jewels, collars, aprons, badges and etc.) if lost or stolen. Or that a suitable insurance provider be entrusted with a jeweler's insurance. This is a substantially more coverage as it will cover actual replacement costs which some home owners' policies will not do.
