MINUTES OF THE 193rd ANNUAL ASSEMBLY GRAND COUNCIL OF CRYPTIC MASONS OF THE STATE OF NEW YORK

The 193rd Annual Assembly of the Grand Council of Cryptic Masons of the State of New York was held on Friday, August 12th and Saturday, August 13, 2016 at the Lexington Hotel Rochester Airport, Rochester, NY.

OPENING AND RECEPTION OF GRAND MASTER AND OFFICERS OF GRAND COUNCIL:

A Council of Select Masters was opened by the Illustrious Master and Officers of Nundawaga Council No. 92 on Friday August 12th at 7:30 PM. The Officers of Grand Council were received into the Council and formed lines for the reception of the Right Illustrious Garry R. Hutchurson, Acting Most Illustrious Grand Master. Right Illustrious Hutchurson was received and escorted to the East where Grand Honors were accorded. He thanked the Officers of Nundawaga Council for their service this evening and asked they vacate their stations and the Grand Line Officers assume their stations and places for the Grand Council Annual Assembly.

ENTERED:

The Right Worship Peter A. Flihan, III, Grand Treasurer, representing the Most Worshipful Jeffrey M. Williamson Grand Master of Masters in the State of NY was received and escorted to the East and accorded Grand Honors. A welcome was extended to him by Acting Most Illustrious Grand Master Hutchurson and he was accorded a seat in the East.

OPENING OF THE ANNUAL ASSEMBLY OF GRAND COUNCIL:

In accordance with New York State Fire Laws, the Acting Most Illustrious Grand Master advised the Companions of the exits in case of emergency. He then advised all Companions present that they must register with the Credentials & Registration Committee in order to vote...he advised all present that the Registration desk was located in the lobby outside the doors to the Assembly room.

Acting Most Illustrious Grand Master Hutchurson asked the Grand Recorder if any Councils where not entitled to vote at this Annual Assembly. The Grand Recorder reported that all Councils of this jurisdiction were entitled to vote.

Acting Most Illustrious Grand Master requested that the Grand Recorder call the Roll of the Councils to determine a constitutional quorum was present. Councils present were: Columbian No. 1; Adelphic #7; Rotica #12; Central City #13; Buffalo-Keystone #17; King Hiram #18; Doric #19; Dunkirk #25; Palmyra #26; Ahwaga #30; King Solomon #31; Hornellsville #35; Adoniram #36; Peekskill #55; St. George's #74; SkoiYase #75; Suffolk #76; Faltbush #80; Oneonta #87; Northshore #88; Cayuga #90; Hamburg #91; Nundawaga #92; Goshen #93; and King David #97. Grand Recorder informed the Acting Most Illustrious Grand Master that a quorum was duly present. Acting Most Illustrious Grand Master then declared the 193rd Annual Assembly of the Grand Council of Cryptic Masons of the State of NY duly opened in ample form.

COMMITTEE APPOINTMENTS:

The Acting Most Illustrious Grand Master then appointed a Credentials Committee, consisting of R:I:.Kenneth Lockard #76, Chairman; R:I:.Kenneth Kohlhagen #92; R:I:.Vernon G. Rupert #92; I:.Phillip Valot #76; and R:I:.George Emmons #76 if needed.

The Acting Most Illustrious Grand Master appointed a Committee to reply to the Grand Master's Address, consisting of M.I.David Raymond, Chairman; M.I.Richard Anderson; M.I.E. William Whittaker.

The Acting Most Illustrious Grand Master appointed M.I.Richard C. Anderson as Deputy Grand Master protem for the 193^{rd} Annual Assembly.

RESOLUTIONS:

1] A Motion that the minutes of the 192nd Annual Assembly as distributed in the packet and will be printed on the 2015-16 Proceedings CD as amended be approved by M.: I: Paul B. Matthews.

- 2] A Motion that all Companion Select Masters in good standing be invited to remain as visitors to this Annual Assembly, except at such time as provided by the Constitutions by M.I. Donald Harrison.
- 3] A Motion that the reports of the Elected Grand Line Officers, from Grand Principal Conductor of the Work to the Grand Judge Advocate inclusive, as are printed or will be published on the 2015-16 Proceedings CD, be approved by M∴I∴ Leonard Mason.
- 4] A motion that the Election of Officers be the Order of Business at 1:45 PM on Saturday, August 13, 2016; and that nominating speeches be limited to three [3] minutes and that seconding speeches to two [2] minutes by M∴I∴Francis Karwowski.
- 5] A Motion that our visiting Grand Masters and Past Grand Masters who are not already Honorary Members of this Grand Council be made so by M.I.Richard C. Anderson.

All Motions were made, seconded and passed unanimously. Copies of all Annual Reports can be found in the handout packet at the Registration desk. All other reports will be made as part of the permanent record of this 193rd Annual Assembly upon motion.

CONDITION AND EXTENSION OF THE RITE REPORT:

The Report of the Committee on the Condition and Extension of the Rite was highlighted by R : I : Curtis Banks, Grand Principal Conductor of the Work. On motion duly seconded the report was unanimously adopted and spread upon the minutes.

GRAND LECTURER'S REPORT AND RECOGNITION OF ASSISTANT GRAND LECTURERS:

(Report was given Saturday, August 13th) The Grand Lecturer's Report was given by R.I. Stuart W. Card. A motion was made seconded and passed unanimously to accept the report and to spread upon the minutes. No request for modifications of our present ritual was received this year. Ritual presentation has greatly improved over the past few years. So we see an upward movement in a positive way with performing the ritual. Still work to be done.

The Assistant Grand Lecturers were recognized and each personally thanked by the Grand Master for their work in the past Cryptic Year, and given Grand Honors.

REPORT ON THE WEB SITE:

A report on the Web Site was given by R : I: John Gallant, Webmaster; a motion was made, seconded and passed unanimously to accept the report and to spread upon the minutes.

REPORT OF THE COMMITTEE ON MASONIC EDUCATION & COMMUNICATIONS:

The report was given by R:I: Curtis Banks. On motion duly seconded the report was unanimously to accept the report and to spread upon the minutes.

LIBRARY AND MUSEUM COMMITTEE REPORT:

The report was given by R.I.Phillip Chandler. On motion duly seconded the report was unanimously to accept the report and to spread upon the minutes.

RITUAL COMMITTEE: (Report was given Saturday, August 13th)

R∴I∴Stuart Card reported that there is no written report since no changes to the Ritual were presented this year as he mentioned in his Grand Lecturer's Report.

REPORT OF THE GRAND HISTOTIAN:

R.:.I.: James Reichman was not present and No Report was given in written or oral form.

JURISPRUDENCE AND BY-LAWS COMMITTEE:

M.: I.: E. William Whittaker, Chairman gave the following report: The committee recommends the approval of the By-Law change for Buffalo-Keystone Council No. 17. The Committee recommends the approval of the merger between Doric Council No. 19 and Palmyra Council No. 26 to be known as Doric Council No. 19 with its By-Laws and Structure and Officers. On motion duly seconded the report was unanimously adopted and to be made a part of the annual proceedings.

REPORT OF THE GRAND FRATERNAL CORRESPONDENT: (Information Only)

M.I.Paul B. Matthews stated that No Report was prepared. He did not received anything from the Grand Representatives nor from the Grand Jurisdictions, except two from M.I.E. William Whitakker of Oklahoma and R.I.Donald Brugger of Texas. He mentioned that he would address this by securing where possible the information directly from the Grand Recorders of the Grand Jurisdictions we are in fraternal relations with for next year.

REPORT OF THE GRAND TRUSTEES: (Report was given on Saturday August 13th)

M.:.I.:Richard C. Anderson on behalf of the Trustees of Grand Council presented the Annual Trustee Report which was printed and in the packet. On motion duly seconded the report was unanimously adopted and to be made a part of the annual proceedings.

REPORT OF THE GRAND TREASURER: (Report given on Saturday, August 13th)

The report on the 2015-16 Operating Budget (Income and Expenses), the full reports were printed in the handout packet was given by M.·I.·Donald Harrison, Grand Treasurer. M.·I.·Roberts made a motion that the reports be accepted and spread upon the minutes as printed in the handout packet, was seconded and passed unanimously. M.·I.·Harrison spoke on the Escrow Funds and that it will take a year hopefully to update these with appropriate transfer of funds from the Operating Account because of the unavailability of funds for the past several years. But with the increase in Per Capita in place we should have funds available to get these accounts up to date hopefully.

REPORT OF THE AUDIT COMMITTEE: (Report given on Saturday, August 13th)

The report was printed in the handout and R : I : George Emmons on behalf of <math>R : I : Kenneth Lockard asked that it be spread upon the minutes as printed, the motion was seconded and passed unanimously.

THE BUDGET COMMITTEE REORT:

The report was printed in the handout packet and M.·.I.·. Harrison and M.·.I.·. Roberts asked that the proposed 2016-17 Budget be accepted as amended and spread upon the minutes as printed, passed unanimously. The Budget was amended prior to opening the Annual Assembly at the Grand Line Officers workshop---i.e. Amend Line E-2 to \$2,800.00, each Grand Line Officer except MIGM to receive \$400.00 for the year. Amend G-1 to \$900.00 in order to address the upcoming Triennial in August 2017. There was discussion by the Grand Recorder that he was trying to downsize office expenses for the 2017-18 Budget and maybe adjust some other line items as well.

REPORT OF THE CONCORDANT BODIES AND YOUTH COMMITTEES:

M.:.I.:.Roberts Grand Recorder presented this annual report as printed in the packet. It was moved and duly second and unanimously carried to receive the report and to spread it upon the minutes.

LONG RANGE PLANNING REPORT:

M.I. Richard Anderson speaking on the behalf of the Committee highlighted the Long Range Planning report in the annual packet. He then moved to accept and spread full upon the proceedings of this Annual Assembly motion was duly seconded and carried unanimously.

REPORT BY THE DEPUTY GRAND MASTER:

R∴I∴Garry R. Hutchurson reported that he would give his report at Saturday's session as the Acting Most Illustrious Grand Master.

CALL FROM LABOR TO REFRESHMENT:

The Acting Grand Master ordered the Grand Principal Conductor of the Work to call the Craft from Labor to Refreshment, for the purposes of conducting the Vespers Service. The Assembly will reconvene at 8:30AM Saturday, August13, 2016 for the reception of Distinguished Guests and Ladies, followed by the Necrology Report and remaining business of the Grand Council. All were invited to attend the Hospitality Room following the Vespers Service.

Grand Council Of Florida, 2017 Report

R.:I.:William J. Thomas, Grand Representative of the Grand Council of Florida near the Grand Council of New York.

I was appointed Grand Representative in early 2017, and attended the Grand Council of Florida at its annual assembly in May 2017, at which Benjamin J. Holland, Most Illustrious Grand Master, presided. Right Illustrious Deputy Grand Master Robert St. John, Jr., was elected MIGM, to preside through May 2018. There were about 500 representatives and quests present.

I was introduced as Grand Representative and Past Grand Master, and given private Grand Honors, after which I was elected to Honorary Membership in the Grand Council of Florida. There is no appointed corresponding Grand Representative of New York near the Grand Council of Florida.

The Grand Council is facing similar challenges as the Grand Council of New York: declining membership, retention, education and ritual proficiency. They seem to be in good financial shape. There are about 3300 Cryptic Masons in Florida. A suggestion was made to consider 2-year terms due to leadership needs; no action was taken on the topic.

A review of the Proceedings reflects a significant concern with membership. Membership is down 50% from 10 years ago; and the projection is for another 50% drop over the next 10 years. Many Councils have ceased to exist. Over the past year, the Councils were challenged to engage in some sort of serious education at each and every meeting. There was a positive result of membership and enthusiasm in those Councils which implemented this challenge. Recommendations of interest:

- 1. Every Council should conduct a Table Council annually, with a theme of engaging interest to the Companions.
- 2. The Grand Council's website should add Council education items to challenge the Companions. In addition to Grand Council, I was invited to several local Councils, where I was warmly received. I have seen no degree work. Most local Councils seem to rely on annual or semi-annual York Rite Festivals, where degrees of all three bodies are conducted for the benefit of all District Councils. The Super Excellent Master Degree is done once a year on a statewide basis.

It is noteworthy that the York Rite Grand bodies of Florida all meet on three consecutive days. The schedule provides economy of time and costs, as many of the members have overlapping responsibilities in the three bodies. They meet on Monday, Tuesday and Wednesday; and their order of meeting alternates on a 3-year cycle.

ANNUAL REPORT OF THE JUDGE ADVOCATE 2016-2017

Most Illustrious Grand Master, my Grand Council Companions, and Companions all: The 2016-2017 Cryptic year, was a relatively quiet one from a Masonic legal standpoint. No formal legislation was proposed before the Annual Assembly, nor were any formal opinions issued. Frequent consultations and conferences with the Grand Master were had on general matters, and as in past years, requests for informal advices and opinions were rendered to the Grand Master and to the Grand Recorder's Office, as well as to Committee Chairmen, with the permission of the Most Illustrious Grand Master.

As we have experienced each year, we receive, almost on a regular basis, requests for advice on both Cryptic and general Masonic law from the membership and from Committee Chairmen, and we must emphasize that these opinions are unofficial and gratuitous, as they were not solicited by or through the Grand Master who alone functionally and constitutionally enjoys the prerogative of seeking counsel from the Judge Advocate.

When we receive calls from the Companions requesting legal opinions upon matters of Cryptic law, we prefer to respond to these questions, both as a courtesy to the Companions and as a matter of Masonic education, but it is clearly to be understood that these opinions do not carry the sanction of the Grand Council, and that only the Grand Master may, with any degree of authority, advise the Companions on Cryptic law.

As we have iterated in the past, the proper procedure to secure an opinion is to pose the question in writing to the Grand Master. If he deems it appropriate, he may seek our counsel, and we may be requested to issue either a formal, written opinion or an informal opinion. It should be understood that the Grand Master is the primary source of all Cryptic legal authority in this Grand jurisdiction and while the Grand Council itself is not in session. Where an issue involves civil law, of course, one must retain private counsel.

Most Illustrious Grand Master, we have enjoyed working with and serving you, the Grand Council, and all the Companions this year. We also extend considerable appreciation to our Grand Recorder for his support, counsel, and wise input, and we respectfully move that our Annual Report be entered into the proceedings of this Assembly.

PROPOSED AMENDMENTS

Section 8 of the Constitution provides that a proposition to amend the Constitution may be adopted if submitted in writing at one Annual Assembly, laid-over to the next for consideration, and then consented to by a two-thirds majority vote of the Members present; the amendment, however, may be adopted at the Annual Assembly at which it was presented, if by a unanimous vote.

Section 58 of the General Regulations provides that the General Regulations may be amended by a two-thirds vote of the Members present at any Annual Assembly.

One fact being that the Degrees of Cryptic Masons is not a requirement to become a Knight Templar. Although it was said that the members that belong as Cryptic Masons is needed to complete the Circle of Perfection in the York Rite Masonry, [meaning that part of the story/ Degrees would be missing as we know it]. So Cryptic Masons belong because they want to and to know the rest of the story. This consistency is the same and will continue to be unless changes are made.

At the recent Workshop in Utica, all present had the opportunity to offer what Grand Council needs to do to become more involved and accepted in the Masonic Family. Different issues were discussed. One major change is that this being the last year for election of the experienced Recorder [Rev – Charles M. Roberts]. CONCORDANT BODIES AND YOUTH COMMITTEE 2016-17 ANNUAL REPORT

Most Worshipful Grand Master, Most Illustrious Grand Master, Past Most Illustrious Grand Masters, Distinguished East, Grand Line Officers, and Companions All. This is the Annual Report of the Grand Council's Concordant Bodies and Youth Committee for the 2016-2017 Cryptic Year.

Concordant Bodies

Upon appointment by M.: W.: Jeffrey M. Williamson, Grand Master of Masons in the State of New York the Concordant Bodies Committee consisting of the following individuals of Grand Lodge of NY: M.: W.: Jeffrey M. Williamson, Grand Master of Masons in the State of NY, R.: W.: Charles Catapano, Deputy Grand Master of the Grand Lodge of NY (Chairman), R.: W.: James Kintzel, Grand Marshal of the Grand Lodge of NY; R.: W.: Richard H. Swann, Jr., Deputy Grand Marshal of the Grand of NY; Royal Arch Masons: M.: E.: Raymond Roche/M.: E.: Bruce Testut, GHP, R.: E.: Allan M. Bryant, Jr., GK; Cryptic Rite: M.: I.: Garry R. Hutchurson, MIGM, R.: I.: Curtis A. Banks, DGM; Commandery Knights Templar: SK Frederick A. Beitter, REGC,/ SK Richard Kerimoglu, REGC; SK Stenrick B. Adams, DGC; Scottish Rite: Ill. Peter J. Samiec, Grand Almoner, Ill. David P. Spencer, Deputy for NY State; R.: W.: George Emmons, Past Grand Marshal of the Grand Lodge of NY for Remember The Blue Lodge Program. This Committee did convene three times this year.

The meetings of this committee provide a general round table opportunity for discussions of mutual interest. Membership will change with the annual meetings of the various bodies, except for COD which changes ad hoc. Members of this committee have one vote at the Grand Lodge Annual Communications.

Several focuses for the meetings: to make sure all were aware of pending upcoming and projected dates that each of the Grand Lines can publish to avoid conflicts. The Grand Marshal who is also the Webmaster for Grand Lodge created a calendar that included some of the upcoming events for RAM, joint reception for Cryptic & Commandery in November and the Grand Communications of RAM in March 2018, Cryptic in August 2017 and Commandery in September 2017 and COD in October 2017. AASR reminded that two weeks after Grand Council Assembly there will be the Supreme Council Session in Rochester, NY also.

Discussion took place on how the Shrine and now the Grotto are a concern in not cooperating with overall plan of Grand Lodge. That they are each recruiting members right after becoming Master Masons and not giving brothers enough time to flourish in the blue lodge. The thoughts were shared around the room and the DGM took notes and mentioned that further discussions should continue and to possibly invite them to one of these meetings. The Grand Master reminded us all that the Shrine is NOT a concordant body and our brothers need to be educated in this.

The DGM asks what each of the concordant bodies had to invest in the growth of our body and how it related to Blue Lodge growth. Each representative spoke about programs that were geared to show how the blue lodge is needed and necessary. All representatives agreed not to go after newly raised master masons until after at least 1 year of them being in lodge and then determine what the strength of the lodge is might make the efforts go 2 years or more. This formula will help Grand Lodge identify weaker lodges so they know where their AGL's, Staff Officers & DDGM's need to focus concentration on. It was agreed that while the York & Scottish Rite concordant bodies provide more light, we need to make sure the principles are met that the average Master Mason has received ALL the light and that the concordant bodies fill in gaps to complete the story.

R : W : George Emmons gave us an update on Remember the Blue Lodge Program. The jewels for first line signers and that the program is and has come to an end. He was thanked by all those present and even as those of us who were offering ideas for continuity, Bro. Emmons felt it had run its course and to just let it die out. The new Lewis jewel is making some good hits and advised that we should be concentrating our efforts to that with family bonds.

The Grand Master encouraged the meetings to keep going and was glad that more representation showed up to this meeting then the last one which was poorly attended except for Cryptic which he commended for making sure we had our say. He hoped to see everybody at various events throughout the year and eventually at Grand Lodge in May and then St. Johns Weekend in June.

The respective Concordant Bodies representatives are open to receiving ideas, thoughts or comments from you to present at any of the meetings of the Committee to better the advancement of Freemasonry in this state.

Youth Groups

The three Youth Groups in New York State are: The International Order of the Rainbow for Girls, The Organization of Triangles, Inc., and The Order of DeMolay. They were all active this past year and represented at many Masonic functions and activities throughout the state.

Her charity cause is America's Vet Dogs. Mrs. Gale Gould is serving the Supreme Assembly as Supreme Nature for 2016-18. She presently is the Supreme Deputy/Inspector for NY Rainbow since 2004. The 2017 recipient of the Order of Deborah Award was conferred upon Miss Ariana Altman.

The Organization of Triangles, Inc will hold its 28th Biennial Convention this coming October 6-9, 2017. The State Representative Miss Samantha Miller's term came to a close on October 8, 2016. Report of the District Deputy Grand Master of the First Cryptic District

Firstly, I would like to express my deepest gratitude to the Grand Line members, past and present, for my appointment as District Deputy Grand Master of the Grand Council of Cryptic Masons of the State of New York. It has been a pleasure to work with the Cryptic team this year and I look forward to another successful year.

Here is a summary of observations over the last year I have regarding the Councils in the First District, in alphabetical order. In general, the Councils are vibrant and interested in prospering, each with senior members of the Craft guiding and mentoring the more junior Companions. In general also, I observed some strong ritual work – accurate memorization and emphatic delivery, and some work that was neither and could benefit from additional guidance.

Like many Masonic bodies I have visited in various District Deputy capacities (Lodges, Chapters, and Councils), there can be a broad range of what is acceptable or standard in terms of books and records. The result is that each Council has its own framework and expectations.

<u>Adelphic Council No. 7</u> meets the fourth Wednesday of October, January, March, and May. I visited on March 22nd, 2017. The Officers performed well with a combination of general command of the material and some reading or reference to the ritual during the opening. Right Eminent Past Grand Commander George Harrison is the Recorder and the books and records are immaculate and very well organized.

Adelphic Council has a number of York Right luminaries involved, including REPGC Don Berry, incoming Grand Commander Ritchie Kerimoglu, and Grand Captain of the Host Paul Huck, to name a few. Adelphic Council is an exceptional Council.

I was unable to confirm the filing of the 990N, but I understand this is done annually.

Adoniram Council No. 36 meets on the second Thursday of January, February, and March. Adoniram has gone through many changes recently including moving from Whitestone to Advance Temple in Long Island City, which should be beneficial for the members, since the associated Chapter and Commandery also meet in Advance Temple.

This Council is led by several Companions of the Council including R:.I:. Ari Chisin, R:.I:. James Reichman, I:. Jay Marksheid, John McKoy, and I:. Joe Savaglio. I met with the Council on January 12th, 2017, along with the Deputy Master R:.I:. Curtis Banks and Grand Steward R:.I:. Don Kunego. Nonetheless, only five Companions showed up so the Council was not able to open.

The Recorder was not present, so his books and records (minutes, membership roster, etc.) were not reviewed on the official visit.

The Treasurer was present; I reviewed the checks and ledger, bank statements, Constitution, bylaws, Charter and equipment; the condition of their books and records and paraphernalia is fair to good, and in a nice touch they have custom Council nameplates with Office.

They have filed their 990N, and subsequent to the meeting I was able to review books with the

Recorder. From an administrative perspective they seem to be in pretty good shape. They do have a fair bank balance, and can sustain activity with no income for a decade or so. However, there is clearly an issue with collecting membership dues (they collected dues for five members out of 28) which they need to address.

Over the past two years this Council has made huge strides, but they need to continue bringing new members in, affiliating Companions who want to do the work, and opening regularly with the goal of performing the degrees.

<u>Columbian Council No.1</u> meets on the second Wednesday of January, February, and March. I attended both January and February meetings, but business travel in March precluded some Masonic activity for me, including the conferral of the Super Excellent Master Degree in March. My Official Visit was the night of January 11^{th,} 2017. All paperwork and books were in order, complete with proof of the filing of the 990N. Books and records are complete and in good shape.

Ritual work in general at Columbian is quite excellent, with most if not all of the work memorized and delivered with authority and passion. All the seats of the Line are committed and it is unusual for any position not to have its elected or appointed Officer attendant. Fellowship follows every meeting with a dinner, with opportunity to engage in educational discussion. Generally the equipment is available and in good shape, but the Charter is quite old and battered and should be replaced.

Columbian Council also has the unique distinction that it performs the Most Excellent Master degree each year, which usually hosts Companions from the First District as well as visitors.

Flatbush Council No. 80 meets the fourth Tuesday, September through June. However, Flatbush Council meets on the same night as its Commandery of Knights Templar, so more focus may be given on the night of the meeting to one or the other, depending on the work of the evening (for example conferring the Royal Master versus the Order of Malta). I visited Flatbush on November 22nd, 2016. Again, a very strong culture and a close-knit group of individuals working to enrich both Flatbush Council and Bay Ridge Commandery. Several senior members of the York Rite Grand Bodies (including R:.I:. Curtis Banks) are involved in this Council as well, contributing to the stability of the Council. The junior Companions and Officers generally speaking are quite solid with the ritual work and are passionate about their involvement. You really get the sense that the line works hard to be professional in their roles.

The books and records need to be reviewed in depth this year, since many of them were not available at the visit, again.

On July 12th it was my pleasure to join Flatbush at a specially convened Council to conduct the Select Master Degree on several candidates, including the Deputy Grand Master of the Grand Lodge of New York. The Companions of Flatbush did exemplary work.

North Shore Council No. 88 meets the fourth Monday in September, November, January, March, and June. I visited North Shore February 27th, 2017. We were warmly received and dined prior to the meeting with the Illustrious Master David Diamondstein and several of the Companions. During

the opening, there was a combination of Companions who had some command of the material while others resorted to reading. However I appreciate the strong culture and close fellowship of the Companions and there is great history to the Council and the other York Rite bodies associated with this location. Also, the Companions and Sir Knights in the other York Rite bodies in the area are quite involved.

North Shore has a core group of stalwarts, and the condition of their books and records is fair to good, and paraphernalia is excellent, however the evening of the first visit in November neither the Treasurer nor Trustee was present to walk me through the financials of the Council. It turns out that the Treasurer goes to Florida this time of year, each year, to be with his family and celebrate his birthday. I suggested to the Secretary and Illustrious Master that they should avoid November for the official visit, that being the case.

On the 26th of June I joined the Companions of North Shore to present a new reproduction of the North Shore Charter, provided by the will and work of our Grand Recorder MI Charles Roberts and our Grand Master MI Garry Hutchurson. The previous charter had been damaged in the fire which destroyed much of the original Lodge building and all associated body documents and paraphernalia. The Companions were exuberant and reinvigorated to do the work of the Council.

<u>Suffolk Council No. 76</u> meets on the second Friday of September through June (except April). My visit was scheduled Friday the 13th of January in 2015. This Council is a pleasure to visit – I was quite warmly greeted and quite a few Companions showed up for both the visit as well as the dinner beforehand. The Council finished the evening by presenting a custom ordered cake with a welcome written in icing!

The books and records are in good shape, the paraphernalia and equipment is also in good condition. Suffolk Council No. 76 is a class act and always a pleasure to visit.

In summary, the books and records of the First Cryptic District, as well as the paraphernalia are in good condition with some follow-ups to be performed. With one exception all Councils have filed their 990N's. In two cases and possibly three (North Shore and Columbian, possibly Suffolk) need replacement Charters.

The ritual work of the First District is quite solid, with exceptional standouts as well as some room for improvement. My perception is that all Companions are interested in improving their work as well as open for additional educational opportunities. I look forward to visiting all the Councils again this year and continuing my support for the District.

No one who goes and does this for the council ever did secretary or treasurer work in their private life, most times both the secretary and the treasurer don't have the experience to do the jobs. Most of your secretaries and treasures are the oldest members and don't come out to meetings.

This is even true for my own council which I am trying to fix now. It very hard for one mason to confront another mason who has 30 plus years and question their ability, most times you take their word. Most times these jobs are just past off to another mason after a secretary or treasurer has died and they didn't want the job to begin with, it's just has to be a name in the position.

I do see hope as my RAM are bring in younger men who are eager to learn and take part. They have expressed their desire to move on to the council and commandry. I also hope that this new push to try and bring in new members to the blue lodge, that they in turn point to us as the further learning in masonry.

This is my annual report as the District Deputy Grand Illustrious Master for the 6th Cryptic District of the Grand Council of Cryptic Masons of the State of New York during the 2016-2017 Masonic year.

I followed the same program for each of my official visits. This included the greetings from the Grand Master and the presentation of his "If we build it they will come" message. I then followed with a discussion of all our Cryptic Mason programs. I ended each visit with some personal comments about my work in the quarries the past 45 years. For details of each official visit see the report for each specific Council.

On August 12 & 13 I attended the Grand Council meeting in Rochester and attended all required meetings.

September 14 I attended Central City Council #13 for my District Deputy Apron presentation and then performed the part of Adoniram in the conferral of the Royal Master Degree.

September 16-18 I attended Grand Commandery and attended the Grand Council meeting that weekend.

October 12th I attended the 6th Cryptic District Grand Lecturer's Convention at Central City Council # 13 in Liverpool. The Grand Lecturer gave an elegant presentation on the Super Excellent Master Degree and then conferred the degree in short form to all the companions present.

October 17 I made my official visit to Rotica Council #12 in Vernon. This Council is strong and capable of performing both Royal & Select Master degrees.

October 21 my wife and I attended the Grand Master's reception at the Rochester Airport Hotel and participated in all the festivities of the evening.

On November 10 I fell and suffered a severe injury to my spinal cord at the T10 level which has required two surgeries and continued rehab and medical care since. I remain partially paralyzed in both legs and suffer from continual sciatica. Recent MRI's and Nerve testing suggests that these will be continual life-long problems. My rehab has been complicated by multiple falls, two different R knee injuries, bursitis in both hips, R plantar fasciitis, and a new ruptured disc at the L4 level. These injuries have caused me to miss some Masonic meetings and responsibilities this year and I have been forced to cut back on future Masonic responsibilities and roles.

On November 15, against my wife's and my doctor's wishes, I attended my official visit to King Hiram Council #18. Over the past 5 years I have been one of many who have helped the late RI Don Ellinwood and MI E. William Whittaker in keeping this Council alive. Although we did not have enough companions to open, I inspected the books and found everything in order. The exciting news is that 7 new candidates for the Cryptic Degrees from Auburn Lodge will join the several members of Auburn Lodge who have taken the degrees in the past two years. The plan is to move this Council from Seneca Falls, where it has met temporarily for the past few years after the Port Byron Lodge was condemned, to a new home at the Auburn Lodge. See my notation from June 13, 2017 for the latest on this rehabilitation of a failing Council.

March 8 I attended my official visit to Central City Council #13 in Liverpool. This Council is strong and conferred both the Royal & Select Master Degrees this Masonic year.

April 12 I attended Central City Council #13 and portrayed the part of King Solomon for the Select Master Degree.

April 26 I made my Official Visit to Fulton Council #50 in Phoenix. 7 members attended and the Grand Marshall, RI John Gallant, who was simultaneously making his Grand Line Officer visit, and I made 9 to officially open. This is the first official visit in several years that this Council did not have at least 9 members present. The active members of this Council are older and some are dropping out due to deaths and health issues. This Council has not conferred the degrees in years. They have no new candidates, despite some efforts to find some. They are doubling down this year to find some candidates as the companions of this Council are aware they need new blood.

May 25 I made my Official Visit to Kind David Council #97 in Dexter. This Council is strong and doing good work. They are capable of conferring both degrees.

June 13 I attended the rededication of King Hiram Council #18 in Auburn. This meeting was attended by the Grand Master and several of his Grand Line, who presented King Hiram Council #18 a new warrant, as their original was lost in the condemned Port Byron Lodge in years past. This council voted to change it's bylaws to meet permanently at the Auburn Lodge and they have a full line of younger and eager officer's. The Grand Master then installed the officers of King Hiram Council for the ensuing year. This Council, which has been so close to losing their warrant the past few years, now has a bright future.

June 14 I participated in the installation of officers of Central City Council #13 in Liverpool.

If called by the Grand Master this upcoming Masonic year and if my back cooperates, I anticipate serving the Grand Council for my 2nd year as District Deputy.

Grand Council of Cryptic Masons of the State of New York Grand Lecturer's Report for 2016 – 2017

Conventions were held in 4 of 7 Districts. All host Councils turned out a good crowd of their own members (some also recruited participants from other Councils). Most opened and closed, *either* without errors *or* without using a book, so keep at it! ©

The Convention focus was the Super Excellent Master degree ritual, history and symbolism. The earliest reliable record of the conferral of this degree was by our own Columbian Council #1 on December 22nd, 1817, so we are approaching its bicentennial. We encourage each District, perhaps in conjunction with one of its adjacent Districts, to confer it before the end of the Cryptic year now beginning, and Grand Council will help!

As a full-form conferral requires at least 30 participants, most Councils, indeed most Districts, feel it is beyond their capacity. Yet there are options to make it feasible. Columbian Council has developed a version, also performed with great flair by a team from Western New York, which consolidates some of the spoken lines, so that a smaller cast can perform the drama, without losing any of the content; this version can be used at will by Columbian Council and with a dispensation from the MIGM by other Councils.

Our Grand Council has also long permitted a very short form, which omits the drama entirely. Why would you use such a mutilated form of this impressive degree? So you can confer it upon a large group of Companions, who can then study its ritual, and a few months later perform the full dramatic form of the degree! At the Convention in the 6th Cryptic District, we conferred the short form on enough Companions to form a cast for a full form conferral this coming Cryptic year. Think how exciting it would be, especially for our newer Companions, if you were to do the same in your District? Again, we will help!

If I am re-appointed, that (plus any other ritual topics requested by the Companions of the District) will be the work of the Conventions in the coming year. Also, Grand Council will work, through our District officers, with the Councils, to offer degrees in venues that reinforce their impact (such as the Select Master in actual caverns or tunnels).

My job and that of all the Assistant Grand Lecturers is to *help* the Councils in the primary function of Cryptic Masonry: by performing ritual competently and with feeling, to transform the hearts and minds of Companions, making us all ever better ashlars.

Our ritual is what distinguishes us from all other organizations. It is the means by which we transmit the unique message of Cryptic Masonry. It is the structure into which we pour our energies to provide the transformative experiences our ceremonies should be, that they *must* be to have any value. Whatever else you do in Cryptic Masonry, we ask you to remember the central and essential role of our ritual, and to give it the respect, attention and effort it deserves. This starts with the opening: experienced members need to exemplify this and train our eager newer members to do it in a manner that prayerfully attunes the minds of all Companions present, preparing them to perform effectively and benefit abundantly from the Masonic work of our Assemblies.

The Annual Report Of The Grand Recorder 2016-2017

Most Illustrious Grand Master Hutchurson, Grand Line Officers, Past Most Illustrious Grand Masters, and Companions all:

This year as in the past was a very busy year in the Office of the Grand Recorder. I have continued to work on the files of the Grand Council Computer cleaning up items and creating new files for storing information. The Computer has become much more efficient and is easier to find things.

We did bring to a successful conclusion the issue with the former Marriott Hotel in Islandia, NY with regards to the contractual arrangements. The Grand Council owes a debt of gratitude to Companion Harold Trabold who gave numerous hours of his law practice experience free of charge to making this happen. Our Grand Council has been truly blessed because of his services. We did not incur any major financial obligations with this issue

Communication is a major task of the Grand Recorders Office. I have kept up with all the written and verbal communications. Many hundreds of emails, letters and phone calls have been addressed on various matters by the Grand Recorder this year. I have assisted Recorders and Grand Line Officers with needed information to make their roles easier and more efficient.

All Grand Council Membership Numbers have been assigned and Recorders have been informed. The 2016-17 Grand Council Membership numbers have been finalized and Recorders should be receiving them shortly. I wish to thank the Recorders who have submitted their Rosters on Membership for the Grand Recorder's Office. Several others still need to do so in order for the Office to do a comparison to the last known data it has on membership. I received from former Grand Recorder Pozefsky this year a disk on membership rosters of Councils from 2012. This will help to develop an accurate membership data base in order to proceed forward with entering the Membership Solution program (former YRIS) of the Grand Encampment of the Knights Templar of the USA. We are hopeful to enter into this process this year thereby creating a new efficient way of tracking membership data by local Recorders and the Grand Recorder's Office.

The Office this year had paid to have several boxes of historical Annual Returns and Election Certificates scanned to eliminate storage space and for them to be much more accessible. Such work will continue this year to further efficiency and storage costs. A major task this year will be to begin the scanning of the old file cabinet (3x5 Membership cards) in order to reduce further storage of this item.

The Office continues to track and keep current all Grand Representative Appointments. I wish to thank R.I.John Gallant for his continued support and assistance with this program.

The Office has developed a new electronic template for Grand Council Warrants. This was used this year to issue new duplicate warrants to Northshore Council No. 88 and King Hiram Council No. 18.

With regards to the financial condition of this Grand Council. With the recent increase in Per Capita this Grand Council is on a solid financial ground for the future. We have enough income at present to meet all our current expenses and a surplus to stabilize past year deficits. This year we hope to balance all outstanding escrow accounts for money due them and we have begun a process to reduce expenses in the 2017-18 Operating Budget. Please see attached the Grand Recorder's Financial Ledger for revenue received and vouchers issued for expenditures for details.

Finally, I commend most recorders to getting their Annual Returns submitted in a timely manner. I only had nine to remind several times to get them in. We have made great strides forward on this front too. Let us continue to build on this solid foundation as we move forward into the future as a Grand Council.
