**Charity** has been considered to be one of the greatest Masonic virtues.

In 1950, the Most Illustrious Grand Master George W. Pratt was responsible for the formation of the Grand Council Charitable Fund. The Grand Council Charity Fund was incorporated in 1961. The Charity Fund in 1962 adopted as its principal project that of finding a cure for Parkinson Disease. Presently we continue to devote the majority of our charitable giving to research to eradicating this disease.

Since the inception of the Charity Fund we have established an investment portfolio that is over a 1/2 million dollars, of which, the yearly earned interest thereon is available for use for operational expenses of the Charity Corporation and its annual donations to approved programs.

What follows is a brief description of the approved Charity Fund Corporation programs for receiving a annual charitable gift.



Parkinson's disease (PD) is a chronic and progressive movement disorder, meaning that symptoms continue and worsen over time. Nearly one million people in the U.S.

are living with Parkinson's Disease. The cause is unknown, and although there is presently no cure, there are treatment options such as medication and surgery to manage its symptoms.
